B. Eligibility / Qualification Criteria:

- a) The bidder shall have to provide services required at New Delhi / Delhi.
- b) All bidders must enclose VAT registration / service tax registration certificate along with the tender documents.
- c) Only registered Recyclers/Reprocessor of e-waste with Central Pollution Control Board (CPCB) Ministry of Environment & Forest (MOEF) are required to participate. They will have to submit the copy of certificate to this effect along with tender paper and this certificate must have the validity on the last day of submission of Bid.
- **C.** <u>Period of validity of bid</u>:-The bid shall remain valid for 90 days after the date of bid opening. If any bidder withdraws his tender before the said period shall without prejudice to any other right or remedy, be at liberty to forfeit the Bid Security absolutely.

D. General Terms and Conditions:

- 1. The bidders may inspect the items on a predetermined date as given in Bid Schedule and satisfy themselves about the items they are bidding for. For inspection of items under auction at NIELIT, Electronic Niketan, 6, CGO Complex, New Delhi 110003, the bidder may contact Sh. B. B. Dua, Dy Director (Tech.).
- 2. The items shall be sold to the bidder found highest bid value in totality.
- 3. The Earnest Money Deposit of the successful bidder shall be adjusted in the bid forthwith. The EMD of unsuccessful bidders shall be returned within one month of the auction date, without any interest.
- 4. No items, once disposed to the successful bidder, shall not be taken back by O/o NIELIT.
- 5. The successful bidder has to make full balance payment in the form Demand Draft in favour of NIELIT, New Delhi within 3 three days after confirmation, failing which the offer will be cancelled and EMD shall stand forfeited.
- 6. An Earnest Money Deposit (EMD) of Rs. 6,300/- (Rupees Six Thousand Three Hundred only) must accompany each quotation. This shall be in the form Demand Draft/Pay order of any Nationalized /Scheduled Bank drawn in favor of NIELIT payable at New Delhi without which the tender shall be summarily rejected. No Cheque / Money order / Cash shall be accepted. The EMD deposit shall not attract any interest.
- 7. The successful bidder shall be required to lift all the items from the disposal site to his premises within 3(Three) days after the payment of the quoted amount (EMD amount will be adjusted with the quoted value). On failure to do so, O/o NIELIT, New Delhi shall have the right to forfeit the entire amount of the bidder and dispose the items to alternate bidder.
- 8. The successful bidder shall deposit the total amount calculated based on their quoted rates within 3 days of receipt of letter/e-mail communication from NIELIT. A copy of this document (terms and conditions) with each page duly signed by the authorised signatory, who has signed the bid should be submitted with the quotation in token of acceptance of the terms and conditions.
- 9. Incomplete and unsigned quotations will be rejected.
- 10. The Successful bidder need to submit an undertaking that all the e-waste will be disposed off as per E-waste(Management and Handling) Rules,2011 notified by M/o Environment & forest.

E. Bidding Procedure:

- a) Sealed Bids shall be received, not later than **15.00 hrs on 30th January, 2015**. No Bids will be accepted after this date & time under any circumstances. This office will not be responsible for any postal/courier delay and also for reasons beyond the control of this office.
- b) The bids would be opened at **16.00 hrs on 30th January, 2015**. The bidders can depute their representatives to attend the bid opening event.
- c) All bids must be delivered to the office of NIELIT, Electronics Niketan, 6 , CGO Complex, New Delhi 110003.
- d) All relevant rules and regulations of Government of India will be final and applicable & binding on all bidders.

F. Submission, opening and evaluation of Bids:

- a) The Bidder shall submit their bid in the prescribed proforma enclosed as Appendix I to this document;
- b) The bidder shall be required to quote for all items. In case the bidder has not offered their rates for any item listed in the proforma, the bid shall be treated as incomplete and summarily rejected;
- c) The rates should be quoted in Indian Rupees and should be clearly legible. In case of any ambiguity, NIELIT shall have the authority to reject the bid.
- d) The rates must be quoted in figures as well as in words. In case of any inconsistency in the rates quoted in figures and words, the rates quoted in words shall be taken as correct.
- e) Any over-writing/cutting/fluiding should be authenticated by the signatures of the individual, who has signed the bid. Non-adherence will lead to rejection of the bid.
- f) A copy of the terms and conditions (with each page duly signed by the authorised signatory signing the bid) must be attached with the Proforma containing the rates quoted.
