

## **CORRIGENDUM IN RESPECT OF PRE-BID MEETING HELD ON 10<sup>TH</sup> FEB'15**

Kindly refer the pre bid meeting held on 10<sup>th</sup> Feb'15 regarding tender for purchase of Hardware/ software and Forensics tool for Creation of computer forensics investigation Facility at SFIO vide tender no. NIELIT/CCU/Tech/40/12(P2-1). Following amendments are made in the tender.

- i) Items in category-1 are divided in to two categories i.e. item no.-1 (server) and item no.-2, 3, 4 (labtop, desktop and windows server 2012 advanced). Thus, there will be four categories in all and the venders may apply for all or either of the categories or for any combination of categories. Accordingly the Annexure 'D' and 'E' stand changed as appended below. The L1 will be evaluated as per annexure- E below.
- ii) Delivery time in case of category-4 is extended from 4 weeks to 10 weeks.
- iii) In case of category-1, the delivery time is extended from 4 weeks to 6 weeks.
- iv) The EMD has also been revised in case of category-1 and category-2 as mentioned in the appended annexure-D below.
- v) Delivery period for the rest of the item shall be four week.
- vi) Financial bid should be submitted separately in separate envelops for each category.
- vii) In case of category-2 (Apple Mac), OEM authorized bidder certificate is waived off.
