OFFICE ORDER

With the approval of Competent Authority, it has been decided that an extension Centre of NIELIT may be set up at Bhubaneswar in the 5000 Sq.ft. carpet area provided by Govt. of Odisha at OCAC Tower at Bhubaneswar.

2. For this purpose Shri Umakant Tripathi, Assistant Director (EDP) is hereby transferred to Bhubaneswar with immediate effect. He will report to Director, NIELIT, Kolkata Centre.
3. On transfer of Shri Tripathi from HQ to Bhubaneswar, Shri Satish Chandra Kandpal, Assistant Director (Admn) will look after the work related to Public Information Officer (PIO) under RTI Act, 2005.
4. As the transfer to Shri Tripathi is in the public interest he will be entitled for applicable transfer benefits.
5. NIELIT Kolkata Centre will maintain separate accounts for expenditure on renovation/refurbishment, furniture / fixture, electrical, networking and all other expenditures towards setting of of Bhubaneswar Centre and may later claim for reimbursement from HQ.
6. Once NIELIT Bhubaneswar Centre becomes operational, all the projects of Govt. of Odisha will be executed by Bhubaneswar Centre and the income/expenditure will be booked by Bhubaneswar Centre itself.
7. Shri Jayant Chakraborty, Joint Director, NIELIT Kolkata Centre will continue to act as Nodal Officer for NIELIT Bhubaneswar Centre.
