- 1. The quotation should be addressed to the Director In-charge, NIELIT, Aizawl.
- Technical Bid as per Proforma-I and Commercial Bid as per Performa-II are to be sealed in separate envelopes appropriately superscribed as 'Technical Bid' and 'Commercial Bid' respectively as the case may be and then both these covers should be sealed in a cover superscribed as 'Quotation for Alluminium Partition and Doors' and should bear the enquiry number and due date on the top, otherwise Quotation will be summarily rejected. The Commercial Bid would be opened only after the Technical Bid is found satisfactory and qualified. Tender received after the prescribed cut off date and time will be rejected forthwith.
- 3. Rates offered should be valid for a minimum period of 180 days from the date of opening of Tenders. If there is any deviation in the prices written in figures and words the price indicated in words shall be considered as final.
- 4. Repeated Order for part or whole of the mentioned items, if necessary, may be placed within 1 year of acceptance of the item and has to be executed by you, on the same rates, terms and conditions.
- 5. Warranty: The equipment supplied shall be free of all manufacturing defects and under warranty for a period of minimum 1 year wherever applicable.
- 6. NIELIT Aizawl does not bind itself to accept the lowest or any tender and reserves with itself the right of accepting the whole or any part of the Tender and the Bidder shall be bound to supply the accepted items at the rates quoted.
- 7. On taxable items of supply, Sales Tax shall be shown separately. NIELIT Aizawl would be eligible for concession rates as applicable to educational institutions run without profit motives. Necessary and relevant certificates will be issued in this regard at the time of supply.
- 8. Tenders shall be preferably been typed and should be free from typographical errors. All documents should be signed and seal by the bidder or his/her duly authorized representatives.
- PAYMENT TERMS:
 - No advance payment will be made at any cost. Quotation of tenders demanding advance payment and clearance through Banks will not be accepted.
 - b) 100% payment shall be made on receipt of invoice after installation and successful testing of the equipment by the consignee.
 - c) For claiming the payment the following documents would be produced before paying authority.
 - i) Invoice
 - ii) Satisfactory Installation certificate by the suppliers duly signed by the user
 - iii) No payment will be made for goods rejected at site on testing
- 10. The Bidder shall sign the tender at the space provided in the tender form and affix his office seal and indicate the date, otherwise the tender is liable to be rejected.

- 11. The rate quoted by the Bidder shall be final and no enhancement shall be allowed under any circumstances.
- 12. NIELIT Aizawl reserves the right to reduce / enhance the quantity of the equipment for which quotations are being invited.
