Spot Auction of Obsolete E-Waste items will be conducted on 02.05.2024: 11:00 AM at National Institute of Electronics and Information Technology (NIELIT), Calicut.

Interested parties who are authorized or permitted by Central or State Pollution Control Boards for dealing with E-Waste may participate in the Auction process. Parties may be allowed visual inspection of the items on 02.05.2024: by 10:00 AM to 10:30 AM.

Parties should satisfy themselves that they satisfy all conditions of the auction process, before participation. **Pre-Qualifications/Conditions:** 

The participating parties should produce copy of the following documents: -

- Valid License or Authorization or Permission to deal with E-waste by Central pollution Control Board of the Government of India/ State Pollution Control Boards of State Governments. The validity of the license/authorization/permission should cover the period from the date of bid till disposal of the e-waste.
- 2. The license/authorization/permission should be complete enough to cover the type/nature and quantity of the e-waste.
- The bidder should have previous experience of disposing of e-waste of similar organization like Government
  Organizations/Engineering Colleges/Institutes etc. Proof of involvement in the form of certificates from the concerned
  Organizations should be attached with the bid form.
- 4. The bid should be valid upto 30 May 2024.
- GST Registration Details.
- 6. Photo copy of PAN Card.
- Duly Signed Authorization and photo Identity Card of the person (AADHAR card/PAN card/Driving License etc), who is representing the party, participating in the auction is required to be submitted before auction.
