- **Interview Date & Time shall be communicated to the eligible candidates on the email id provided in their application forms.**
- **The Candidates are advised to read and comply all the points of this T&C carefully before applying. Any noncompliance shall result in rejection of the application.**

1. Applicants are required to go through the Eligibility criteria carefully and ascertain their eligibility.
2. No. of posts advertised may vary depending upon requirement.
3. The posts advertised are against and co-terminus with the project- "Setting up of NIELIT Center, Tirupati".
4. The engagement shall be on contract basis, initially for 06 months & extendable based on performance/requirement. Further, the performance of the candidate will be reviewed in every Six months, if not found satisfactory, the contract of the candidate will be terminated.
5. The engagement shall be liable to terminate at any time by giving notice of 15 days from either side or payment of proportionate remuneration in lieu thereof.

 - Resume of the candidate
 - Self-attested experience certificate (including the experience letter from the current place of working), as applicable
 - Last three-month Payslip or Bank Statement of the last three months showing salary credited, as applicable
