Sub: Formulation of Policy for Setting up of New Centres

The issue of having a standard policy for setting up of new NIELIT Centres has been attracting the attention of the management of NIELIT. After careful examination of the matter, it has been decided with the approval of Competent Authority to constitute a committee with following composition for formulation of a policy for setting up of the new NIELIT Centres/Extension Centres at different locations:

- i. Dr. Samsher, Director, NIELIT Gorakhpur- Chairman
- ii. Shri V. Krishnamurthy, Director-in-charge, NIELIT Chennai- Member
- iii. Shri Himanish Roy, CFO/JD(Fin), NIELIT HQ- Member
- iv. A nominee of DEITY- Member
- v. An external member from Academia
- *vi. Shri Anurag Kumar, Dy. Director(Projects), NIELIT HQ- Member Secretary

2. The above Committee will prepare a policy note for establishing new Centres and Extension Centres, taking into account the following factors:

- i. Demography and topography of the place
- ii. Long term sustainability and financial viability
- iii. Creation of posts
- iv. Availability of land at free-of-cost or at minimum-cost basis
- v. Financial support from central/state government for acquiring land, infrastructure development and maintenance of building
- vi. Suitability of land location and support from State Governments
- vii. Feasibility of candidates approach to undergo trainings

3. The Committee may co-opt any external/internal member for expert advice.

4. The Committee shall submit its report within 15 days from the date of issue of this OM.
