The Institute is presently engaged in implementation of national level schemes for Education & Training in Computers, Bio-Informatics, Computer Hardware, ITES- BPO, Embedded Systems, VLSI Design, Multi-media and Animation, amongst other programmes.

## **Qualification and Experience for Direct Recruitment**

Post Graduate in any discipline, or Graduate with PG Diploma in Management. He should have 12 years experience in a responsible position in the field of Personnel Management, Financial Management, Labour Laws. He should have experience of organising senior Level meetings and should be familiar with the Govt. functioning, exposure to working of Societies, preparation of budget and related matters.

Applications received directly and without the requisite documents will not be entertained.
