- b) The vendor shall have to visit the locations at 1) NIELIT Chandigarh Permanent Campus Ropar, Village Bada Phull, Rupnagar and 2) NIELIT Facility, Plot No. M925, IETE Building, Sector 30-B, Chandigarh to inspect and ascertain the condition of the purifiers and Water Coolers to be maintained. Any upfront charges for repair/consumables of purifiers / coolers, if required, must be included in the Financial Quote to be given by the bidder. No separate charges shall be admissible on any account during the contract period except the amount quoted in the bid.
- c) The AMC shall be comprehensive and shall include all components as well as consumables as required during the contract period for proper functioning of the water purifiers and cooling systems.
- d) Service Provider shall provide direct service and shall not employ sub-contractors.
- e) All the repairs and servicing of Purifiers / Filters shall be carried out on-site at the place where it is located. No filters/water coolers/components shall be removed from site without obtaining prior permission from the concerned NIELIT authorities.

## Disclaimer
