4. Years of Past Experience required: The bidder must have experience for number of years as indicated above in bid data sheet (ending month of March prior to the bid opening) of providing similar type of services to any Central / State Govt Organization / PSU / Public Listed Company. Copies of relevant contracts / orders to be uploaded along with bid in support of having provided services during each of the Financial year.

5. 1. Buyer Added Bid Specific ATC

Buyer Added text based ATC clauses

1.1 The NIELIT Campus is situated at NIELIT Chandigarh's permanent campus at **Vill. Bada Phull, Rupnagar** - 140001. The scope of work includes:

- Mowing, Strimming, Laying, Sweeping, Watering, Weeding, Removal of unwanted Vegetation, Applying Fertilizers, Applying Pesticide, Trimming & Pruning, Planting of new and Maintenance of existing Trees/Plants/Grass and potted plants, Cleaning of Drains and other such activities.
- making garden/lawn/open area more attractive by altering the existing design, landscaping including on the banks of drains, adding ornamental features, and planting trees and shrub

1.2 All consumables required for the work / maintenance including fertilizers, pesticides, seeds, etc. are to be provided by the service provider.

1.3 The vendor should visit the campus before submitting bid.

1.4 Payment shall be made on a quarterly basis within 30 days after satisfactory completion of quarter upon submission of tax invoice.

1.5 In case the work is not found satisfactory, a penalty of 10% of the contract value shall be deducted from the quarterly invoice and the contract may be cancelled by NIELIT by giving one-month notice.

1.6 The duration of the contract may be extended for maximum up to six months beyond initial contract period (subject to satisfactory performance).

2. Certificates

Bidder's offer is liable to be rejected if they don't upload any of the certificates / documents sought in the Bid document, ATC and Corrigendum if any.

3. Forms of EMD and PBG

Successful Bidder can submit the Performance Security in the form of Payment online through RTGS / internet banking also (besides PBG which is allowed as per GeM GTC).
