Dear Sir,

You were awarded FSMA contract for period 19/08/21 to 18/08/22 vide this centre letter no. NIELIT/CH/PUR/115/V-8/2020/7764 dated 16/06/21, for three MFM / Photocopier Machines.

However, you failed to provide the services even after repeated phone calls and emails including attending to faults and refilling of toners / cartridges. No reply to this centre emails and letter No. NIELIT/CH/PUR/115/V-8/2021/13608 dated 25/04/2022 in this regard was received.

Consequently, you were served notice vide this centre letter No. NIELIT/CH/NCPUL-CABA/IIS/Vol-I/2022/18126 dated 18/08/22 vide which it was conveyed that without prejudice to and in addition to other penal provisions as per the order, action shall be taken under Rule 175 of General Financial Rules (GFR), 2017, in case you fail to attend and rectify the faults within 10 days of the issue of this letter, as follows:

- 1. Cancellation of the order.
- 2. Removal from list of registered suppliers and debarment from participation in future procurements for a period of two years.
- 3. Repair / servicing of the photocopier machines / MFM from third party at your risk and cost.

As you have neither executed the work nor given any satisfactory response to this centre notice:

- a) You are removed from list of registered suppliers and debarred from participation in future procurements for a period of two years.
- b) The machines shall be repaired at your risk and cost and the cost of repair shall be deducted from invoices submitted by you, if any.
