Sub. : Terms and Conditions for Supply of Raspberry pi to NIELIT, Chennai Centre.

1. The sealed tenders are invited for the above said item by the Director I/c, NIELIT Chennai, 1st Floor, ISTE Complex, 25, Gandhi Mandapam Road, Chennai – 600 025. Up-to **17/04/2017**, on or before 17:00 Hrs. The specification and terms and conditions for the above said item is enclosed.
2. The sealed cover addressed to Director, NIELIT Chennai containing the tender along with ***duly signed terms and condition*** in original shall be submitted in the office of NIELIT Chennai, 1st Floor, ISTE Building, 25, Gandhi Mandapam Road, Chennai – 600 025.
3. The Cover shall super-scribe “**Quotation for Supply of Raspberry pi to NIELIT Chennai**” and should bear the enquiry number and due date on the top. Quotations received after the due date will not be considered.
4. The validity of the offer is to be kept valid up to **two** months from the date of opening of the tender.
5. The time supply of items shall be essence of the contract. The supply shall be completed within 30 days of issuing the purchase order.
6. Sales tax, octroi or any other tax on materials required for completion of respective item / items shall be payable by the contractor and NIELIT, Chennai Centre will not entertain any claim whatsoever in this respect nor shall be responsible in any way.
7. **Payment Terms:**
*No advance payment (Prepayment) will be made at any cost.
100 % of the bill value to the successful bidder will be made after satisfactory completion of supply, installation, commissioning of the goods at our site and on submission of duly signed OEM warranty certificate.*
8. The supplying of items in general shall be executed as per the description and specifications of item / items as indicated in the Invitation.
9. The quantity shown in schedule of quantities may vary (increase or decrease) during supply. Contractor shall carry out the supply as per the actual requirement. Increase or decrease in quantity of item / items of supply shall be executed by the contractor at the quoted rates. NIELIT, Chennai Centre may add or delete any item of supply as per site condition and is not bound to execute all the item / items of supply order placed.
10. On supplying of all the items, each item of supply shall be jointly inspected / tested by officer-in-charge and the contractor or his authorized representative. All debris, unused materials, painting stains on wall or floor etc. developed at site during course of execution-of-work / installation shall be completely removed and the area shall be left clean by the contractor as directed by Engineer-in-charge without extra cost within seven days from the completion of respective item.
11. On satisfactory completion of supply of items / work, final bill shall be submitted to the officer in charge / Director and the same shall be progressed with the following documents.
Pre-receipted bill in triplicate
Test certificate issued by the officer in charge
Duly Signed OEM Warranty Certificate
Any relevant documents, if any.

12. NIELIT, Chennai Centre does not bind itself to accept the lowest or any such quotation and has the right to accept or reject whole or any part of tenders or a portion of the supply of goods without assigning any reasons. No correspondence in case of rejected tenders will be entertained. Incomplete quotations are liable to be rejected.
13. All questions, disputes or differences arising under and out of or in connection with the contract, if concluded, shall be referred to the sole arbitrator appointed by the Director, NIELIT, Chennai Centre.
14. E.mail/ Fax/ Telegraphic/conditional tender will not be entertained.
15. The rate quoted by the tender should be inclusive of **sales tax, VAT, service tax, octroi, local charges and all other levies, if any**. However, **break up has to be shown clearly**.
16. Deduction of Income Tax at source on application as per provision of the section 194 of the Income tax Act 1961 will be made from the payments to be made to the contractor.
17. The schedule of quantities is only approximate and all the items to be supplied shall be paid for in accordance with the actual measurements.
18. Any damage done to the property of the NIELIT, Chennai Centre during installation of items shall be responsibility of the contractor and it shall be made good by him, at his cost to the entire satisfaction of officer in charge, NIELIT, Chennai Centre
19. All materials to be arranged by the contractor for use, shall be of approved make and shall be as per relevant Indian Standard Specification. Where it is mandatory to use I.S. Marked materials, the same shall be arranged by the contractor accordingly.
