**Note: Bidders are requested to note that non-compliance of the following instructions is liable to render their tender being rejected.**

1. Bidders should put **endorsement** on each page of the tender documents as token of perusal.
2. The bidder should make no alterations and / or addition to the tender papers. **Only typed/ Printed quotations will be accepted.**
3. The tender should be put in two separate sealed envelopes marked as (A) **“Technical Bid”** and (B) **“Commercial Bid”** and both be placed inside a single sealed envelope super scribing Tender Reference No. and date of this tender notice and EMD details. Along with all desired documents, EMD should be placed in the **“Technical Bid”** envelope, failing which the same will be summarily rejected. **“Commercial Bid”** should contain only the **RATE SHEET** provided at **ANNEXURE – II** of this tender. **Commercial Bids of only those vendors shall be opened which are found to be technically acceptable in Technical Bid.** In Commercial Bid, the price of the items mentioned as an option should be provided individually.
4. The bidders will be required to furnish EMD Rs 6260/- in the form of DD / BC drawn in any nationalized bank in favour of **“NIELIT Guwahati”** payable at **Guwahati**. Without the Earnest Money the tender will be summarily rejected. Earnest money of suppliers to whom work is awarded shall be kept as security deposit till total supply as ordered is executed and it may be forfeited in case of (i) non compliance of contract/supply order (ii) incomplete supply (iii) material not supplied as per specifications period. EMD of the unsuccessful bidders will be returned after finalisation of the tender and acceptance of work order by the successful bidder.
5. Items are to be quoted in Indian Rupees only.
6. No Quotation will be accepted by fax, e-mail, telex, or any other such means.
7. Acceptance should be given as per enclosed format without any alterations.
8. All rates quoted will be considered to be inclusive of all taxes and freight of delivery place.
9. The quoted rates shall have to be valid for a period of 90 day(s) from the date of opening of tender.
10. Bidders should submit all supporting documents in favour of information submitted in the tender. Further, copies of all statutory licenses and documents like PAN, GST etc. should be enclosed. All documents submitted should be serially numbered.
11. Partial or selective quotes, conditional tenders would be summarily rejected.
12. NIELIT Guwahati shall be under no obligation is liable to accept the lowest quotation. Further the Director, NIELIT Guwahati reserves the right to reject all or any of the tenders without assigning any reasons.

## **GENERAL TERMS AND CONDITIONS OF CONTRACT**

This tender notice shall be governed by following terms & conditions:

1. **ELIGIBILITY-** To be eligible to participate in the tender, a Bidder should be: -
2. **Experience:** Names and address of the vendor's of at least three clients in India, to whom similar products, services were extended and amount of transaction to such clients in India.
3. **Documentation:**
  - a. The supplier to provide installation manual, user manual, operation and troubleshooting manuals and any other relevant documents applicable.
  - b. Suppliers to provide a pre-installation guide explaining the pre-requisites of the installation of the system along with their technical bid.
4. **NIELIT Guwahati** may allow extension of time if in his opinion the works are delayed by reasons beyond the control of the supplier.
5. **F.O.R. Rates:** The rates quoted should be F.O.R. location of supply and should be inclusive of freight/packing/forwarding and other incidental charges.
6. Quotation with overwriting, alternations will not be considered. **Only typed/ printed quotations** will be accepted.
7. **Validity of Rate:** The rates quoted have to be valid up to 90 day(s) from the date of opening of Commercial bid.
8. **Warranty:** Warranty period shall have to be for at least 1(one) year or as per product description from the date of supply and commissioning. PBG @5% is required to submit by the bidder on submission of Bill for payment with 13 months validity.
9. **Installation and Commissioning:** Free of cost. Installation must be completed within 30 days from the date of issue of Purchase Order. The presence of Service engineer from the OEM representative at the time of installation is essential.
10. **Patent Rights:** The supplier shall indemnify the purchase against all third party claims of infringement of Patent, Trademark or Industrial Design Rights arising from use of the goods or any part thereof in India.
11. **Validity of licenses(if Any) :** Software licensing price or policy (if any) shall be clearly mentioned. All licenses should be perpetual. All the accessories shall be from the same OEM
12. **Opening of Price Bids:** The Price Bid(s) of only those vendor(s) who are found technically qualified will be opened and the same will be opened before the technically qualified vendor(s). The date for opening of price bids will be notified separately.
13. NIELIT Guwahati shall be under no obligation to accept the lowest quotation.

16. **Payment Terms:** Bills can be submitted on successful execution of Work Order along with certification from concerned official of NIELIT for release of payment. No advance payment shall be made under any circumstance.
17. Details of the Taxes as applicable should be mentioned in the quotation clearly. In case of any ambiguity, prices will be considered as inclusive of all taxes.
18. In case of any dispute on account of deviation of the terms and conditions, the responsibility will be of suppliers and the decision of the Director, NIELIT Guwahati shall be binding and final.
19. **DISPUTES:** All disputes lie within the jurisdiction of Guwahati High Court.
20. The Bidder is liable to compensate NIELIT Guwahati for any loss suffered. All penalties imposed should be deposited by the supplier immediately or may be deducted from any amount due to the supplier.
21. The Tender is likely to be rejected because of non-fulfillment of any of the above terms.
22. **Deviation from specification:** If the tenderer makes any deviation from the specification given in Annexure-I the same must be prominently brought out in the body of the tender. If any additional item is needed to meet the specification the tenderer should quote for the total including the additional item required to meet the given specification
