B. Eligibility/ Qualification Criteria:

- a) The bidder shall have to provide services required at Guwahati.
- b) All bidders must enclose GST registration certificate along with the tender documents.
- c) Only Govt. registered firms are eligible to participate .They will have to submit a copy of valid certificate to this effect along with the tender document and this certificate must have

the validity on the last day of submission of Bid.

C. Period of validity of bid:-

The bid shall remain valid for 90 days after the date of bid opening. If any bidder withdraws his tender before the said period shall without prejudice to any other right or remedy, NIELIT Guwahati be at liberty to forfeit the Bid Security absolutely.

- D. **General Terms and Conditions:-** The bidders may inspect the items on a predetermined date as given in Bid Schedule and satisfy themselves about the items they are bidding for.  - a) The items shall be sold to the highest bidder.
 - b) The Earnest Money Deposit of the successful bidder shall be adjusted in the bid forthwith. The EMD of unsuccessful bidders shall be returned within one month of the auction date, without any interest.
 - c) No items, once disposed of to the successful bidder, shall be taken back by the office of NIELIT Guwahati.

- d) All relevant rules and regulations of Government of India will be final and applicable & binding on all bidders.

F. Submission, opening and evaluation of Bids:-

- a) The Bidder shall submit their bid in the prescribed proforma enclosed as Appendix-I.
- b) The bidder shall be required to quote for all items in the list.
- c) The amount should be quoted in Indian Rupees and should be clearly legible. In case of any ambiguity, NIELIT Guwahati shall have the authority to reject the bid.
- d) The amount must be quoted in figures as well as in words. In case of any inconsistency in the rates quoted in figures and words, the rates quoted in words shall be taken as correct.
- e) Any over-writing/cutting/fluiding should be authenticated by the signatures of the individual who has signed the bid. Non-adherence to the same will lead to rejection of the bid.
