Chapter 2: Instructions to Bidders and Bid Terms and Conditions

1. ELIGIBILTY-

- a. Bidders should be reputed Indian Firms/Agencies/ Govt. Licensed firms.
- b. Bidders should submit Manufacturing license or Authorised Distributor / Dealer Certificate from the Original Manufacturing Firm. Company Owned or Company Authorised service centre bust be available in Guwahati for the Quoted Products.
- c. Bidder shall have experience in similar works for last 3 (three) years in NE Region.
- 2. **DURATION OF CONTARCT-** The contract shall be deemed to be enforced from the date of awarding the work order till the completion of the defect liability period.
- 3. **COMPLETION PERIOD** The work entrusted along with extra /deviated items, if any, is to be completed within 60 days from the date of the work order.
- 4. **EXTENSION OF TIME** Director, NIELIT Guwahati may allow extension of time if in his opinion the works are delayed by reasons beyond the control of the contractor.
- 5. **RATES** The rates quoted by the bidder shall be firm throughout the currency of contract (including extension of time, if any, granted). Rates shall cover for charges of material, labour and other accessories and any kind of taxes, fees, duties and insurance etc. that are payable. All rates should hold good for execution of the works at any place irrespective of the floor and height throughout the currency of the contract period.
- 6. **RETENTION AMOUNT** NIELIT Guwahati will retain EMD for defect liability period upon award of Contract. The EMD will be released on successful completion of defect liability period. The EMD of all other participated bidders will be returned after one month of award of contract to the successful bidder.

7. PAYMENT OF BILLS:

- a. **SUBMISSION OF BILLS-** The contractor shall submit their bill after successful installation & certification of works to the Director, NIELIT Guwahati. The completion of works will be certified by the Authorised representative of the Employer. No part bills will be entertained.
- b. **DEDUCTIONS-** Statutory taxes and duties will be deducted at source as per government norms. Further other deductions as applicable as per clauses mentioned in the document will also be made.
- 8. **DISPUTES-** All disputes will lie within the jurisdiction of the Gauhati High Court.
- 9. **FORCE MAJEURE** Force majeure clause shall mean and be limited to the following in the execution of the contract placed by the Purchaser: War/hostilities. Riot or Civil commotion. Earth quake, flood, tempest, lightning or other natural physical disaster. •



Restriction imposed by the Government or other statutory bodies, which is beyond the control of the vendor/contractor and pandemic declaration.

- 10. As per notification of MEITY circulated vide letter no. F.No.33(1)/2017-IPHW..dated :14/09/2017, the minimum local content should be 45.percent to qualify as local or domestic manufacturer or Seller has to ensure that operating system software etc comes preloaded with machine from respective OEM . Any deviation in respect of genuinely and authenticity of OS will attract severe penalty on part of seller as law of the land and contractual provisions. Buyer are also requested to verify the key no of OS etc with server of Microsoft/Linux before accepting machines to avoid complexity at latter stage.
- 11. As per notification of MEITY circulated vide letter no. F.No.33(1) /2017-IPHW..dated: 14/09/2017, the minimum local content should be 40 percent to qualify as local or domestic manufacturer.
- 12. Delivery period: The Delivery Period/Time shall be essence of the Contract and delivery must be completed not later than such date(s). Any modification thereto shall be mutually agreed. The Delivery period for this bid is 60 days from the date of award on contract.
- 13. Liquidated Damages: If the Seller fails to deliver any or all of the Goods/Services within the original/re-fixed delivery period(s) specified in the contract, the Buyer will be entitled to deduct/recover the Liquidated Damages for the delay, unless covered under Force Majeure conditions aforesaid, @ 0.5% per week or part of the week of delayed period as pre-estimated damages not exceeding 10% of the contract value without any controversy/dispute of any sort whatsoever
- 14. The bidder should submit a self declaration to the effect in bidder's official letter head that their agency have not been black listed by any Agency whatsoever till date.
- 15. Bidder must provide Acceptance Letter in Firm Letterhead mentioning acceptance of all the tender terms.
- 16. Bidders should submit all supporting documents in favour of information submitted in the tender. Further, copies of all statutory licenses and documents like PAN, VAT etc should be enclosed.
- 17. Original Equipment Manufacturer (OEM) items if any should be supplied in the original sealed packing of the OEM and should only be opened at NIELIT Guwahati Centre in the presence of Centre's representative.
- 18. The repairing/servicing should be carried out in the office premises it self. However, only such work as which cannot be done in the office premises will be allowed to be done outside with written permission of the Centre-Incharge/Section Incharge & Signing Authority of the Organization only on providing standby equipment at no extra cost.
- 19. Experience of having successfully completed similar works during last 3 (three) years ending last day of month previous to the one in which applications are invited should be either of the following
 - a. Three similar completed works costing not less than the amount equal to 40% of the estimated cost, or
 - b. Two similar completed works costing not less than the amount equal to 50% of the estimated cost, or
 - c. One similar completed work costing not less than the amount equal to 80% of the estimated cost.



- 20. Contentions arising out of issues not mentioned in this tender document will be resolved as per GFR, CVC, Ministry of Finance, Govt. of India and NIELIT guidelines.
- 21. NIELIT Guwahati shall be under no obligation to accept the lowest quotation. Further the Director, NIELIT Guwahati reserves the right to reject any or all of the tenders without assigning any reasons.
- 22. Bidders should submit all supporting documents in favour of information submitted in the tender. Further, copies of all statutory licenses and documents like PAN, GST etc should be enclosed.
- 23. Bidder Turn over Criteria: The minimum average annual financial turnover of the bidder during the last three years, ending on 31st March of the previous financial year, should be as indicated in the bid document. Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant / Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. In case the date of constitution / incorporation of the bidder is less than 3 year old, the average turnover in respect of the completed financial years after the date of constitution shall be taken into account for this criteria.
- 24. OEM Turn over Criteria: The minimum average annual financial turnover of the OEM of the offered product during the last three years, ending on 31st March of the previous financial year, should be as indicated in the bid document. Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant / Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. In case the date of constitution / incorporation of the OEM is less than 3 year old, the average turnover in respect of the completed financial years after the date of constitution shall be taken into account for this criteria. In case of bunch bids, the OEM of CATEGORY RELATED TO primary product having highest bid value should meet these criteria.
- 25. IMPORTED PRODUCTS: In case of imported products, OEM or Authorized Seller of OEM should have a registered office in India to provide after sales service support in India. The certificate to this effect should be submitted.
- 26. Availability of Service Centres: Bidder/OEM must have a Functional Service Centre in the State of each Consignee's Location in case of carry-in warranty. (Not applicable in case of goods having on-site warranty).
- 27. Dedicated /toll Free Telephone No. for Service Support: BIDDER/OEM must have Dedicated/toll Free Telephone No. for Service Support.
- 28. The bidder is required to furnish, along with the bid, all relevant certificates such as BIS licence, type test certificate, approval certificates and other certificates as prescribed in the Product Specification given in the bid document.
- 29. Bidders should put their endorsement (signature and seal) on each page of the submitted documents failing which the bid will be rejected.
- 30. Bidder's offer is liable to be rejected if they don't upload any of the certificates / documents sought in the Bid document.
- 31. Scope of supply (Bid price to include all cost components) : Supply Installation Testing and Commissioning of Goods.



- 32. No exemption on EMD is allowed for this bid. Bid submitted without EMD will be rejected without any further evaluation. Relaxation on price will not be provided to any category of bidder.
- 33. Warranty period of the supplied products shall be 3 years from the date of final acceptance of goods or after completion of installation, commissioning & testing of goods (if included in the scope of supply), at consignee location. OEM Warranty certificates must be submitted by Successful Bidder at the time of delivery of Goods. The seller should guarantee the rectification of goods in case of any break down during the guarantee period. Seller should have well established Installation, Commissioning, Training, Troubleshooting and Maintenance Service group in INDIA for attending the after sales service. Details of Service Centres near consignee destinations are to be uploaded along with the bid. The repairing/servicing should be carried out in the office premises it self. However, only such work as which cannot be done in the office premises will be allowed to be done outside with written permission of the Centre-Incharge/Section Incharge& Signing Authority of the Organization only on providing standby equipment at no extra cost.
- 34. The OEM logo to be embossed on the motherboard. No stickers allowed.
- 35. Bidder financial standing: The bidder should not be under liquidation, court receivership or similar proceedings, should not be bankrupt. Bidder to provide undertaking to this effect with the bid.
- 36. Bidder/OEM must have to submit the certificates of ISO 9001, 27001, 10002, 14001, and 20001, GST, PAN, Trade License, Company/Firm registration& TAN Certificate.
- 37. Manufacturer authorization: Wherever Authorised Distributors are submitting the bid, Manufacturers Authorisation Form (MAF)/Certificate with OEM details such as name, designation, address, e-mail Id and Phone No. required to be furnished along with the bid. The Manufacturer authorization certificate must be tender specific mentioning this bid number failing which the Manufacturer authorization certificate will not be considered.
- 38. Data Sheet of the product(s) offered in the bid, are to be submitted along with the bid documents. Buyers can match and verify the Data Sheet with the product specifications offered. In case of any unexplained mismatch of technical parameters, the bid is liable for rejection. Any deviation on product specification will not be considered.
- 39. Malicious Code Certificate: The seller should provide following certificate in the bid:-(a) This is to certify that the Hardware and the Software being offered, as part of the contract, does not contain Embedded Malicious code that would activate procedures to :- (i) Inhibit the desires and designed function of the equipment. (ii) Cause physical damage to the user or equipment during the exploitation. (iii) Tap information resident or transient in the equipment/network.(b) The firm will be considered to be in breach of the procurement contract, in case physical damage, loss of information or infringements related to copyright and Intellectual Property Right (IPRs) are caused due to activation of any such malicious code in embedded software.
- 40. Items are to be quoted in Indian Rupees only.
- 41. No tender will be accepted by fax, e-mail, telex, or any other such means.
- 42. All rates quoted will be considered to be inclusive of all taxes and freight F.O.R. NIELIT Guwahati . In case of any ambiguity the same will be considered as inclusive all.
- 43. The quoted rates shall have to be valid for a period of 1(one) year from the date of opening of tender.



- 44. NIELIT Guwahati shall be under no obligation to accept the lowest quotation. Further the Director, NIELIT Guwahati reserves the right to reject any or all of the tenders without assigning any reasons.
- 45. Bidder are required to quote for both items of the bid. Partial quoting is not allowed and such bid will be rejected.
- 46. Under MSE category, only manufacturers for goods and Service Providers for Services are eligible if the quoted product is registered under MSE. Traders are excluded from the purview of this Policy.
- 47. Bidders required to submit Technical Bid and Commercial bid separately in sealed packet. The EMD must be submitted with the Technical Bid. Bid will be rejected on non-compliance of this bid submission procedure.
