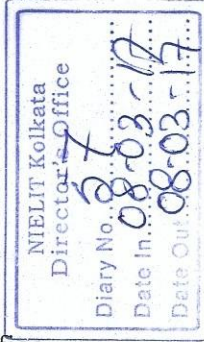

**OFFICE ORDER**
