OFFICE ORDER

Subject: Empanelment of enrolment agencies of UIDAI for facilitating Aadhaar enrolment PAN India

NIELIT is undertaking following critical activities wherein upholding of uniqueness of the identity of the concerned is one of the vital components:

- Examinations of candidates for various courses ranging from IT Literacy to M.Tech level through its network of approved institutions.
- Jeevan Pramaan scheme of Government of India, for providing Digital Life Certificate to the Pensioners.
- Aadhaar based attendance system, as per the directions of Government of India, at all NIELIT Centres.
- Rolling out of various schemes of DeitY in which the assessment and certification from NIELIT is one of component for passing on the benefits to the concerned stakeholders.

In order to maintain the uniqueness of the beneficiaries, UIDAI Aadhaar enrolment is one of the most reliable options available as on date, as Aadhaar is also being used as a unique identity of beneficiaries under various government schemes. NIELIT is also encouraging its candidates / stakeholders to enroll for Aadhaar in order to have a clean set of database.

Accordingly, the agenda item pertaining to invitation and finalisation of RFQ from empanelled agencies of UIDAI for facilitating Aadhaar enrolment PAN India was placed before the Management Board in its 10th meeting held on 13-7-2015, wherein, the approval was sought for invitation of RFQ from UIDAI empanelled agencies for Aadhaar enrolment PAN India (UIDAI States) under centralized mode.

The Management Board has agreed upon decentralised implementation mode and approved that, empanelment of state-wise agency from UIDAI empanelled agencies may be worked out based on applicable government rates. In view of the decision of the Management Board, the Centre Directors are requested to take up the appropriate steps to invite and finalise RFQ from UIDAI empanelled agencies for Aadhaar enrolment in accordance to the pre-defined territorial jurisdiction of states vis-a-vis NIELIT Regional Centres; and roll out the Aadhaar enrolment in all UIDAI states.
