

### **Terms & Conditions:**

1. The qualification of candidates must be from Govt. University or Govt. recognized University/ Institutions.
2. Applicants with last semester result awaited or incomplete degrees are not eligible to apply.
3. Name of the Applicant, Date of Birth in application form must be same as mentioned in the Aadhar Card.

5. Applicants must bring all the original documents, self-Attested photocopies of Marksheets/degrees/testimonials/post qualification experience certificates (including the Experience letter of the current place of working), Valid photo ID on the day of the Document Verification for verification purpose otherwise they will not be allowed to appear in the interview. The cutoff date for calculating age, qualifications, experience etc. will be the last date of submission of the form i.e. 27-01-2026. *In case, last date is extended, the date of determining eligibility will not change.*
