1. The contractual engagement for the position will be on fulltime basis.
2. The contractual engagement is purely short-term and temporary in nature, which shall NOT create any right or claim or preference, either for regular employment in the organization, or for regularization, or extension of period of contract.

4. No TA/DA will be provided to candidates for appearing in the interview.

7. All candidates must appear for document verification and Interview at given date and time only. Date and Time will be updated on website and a mail will also be sent on registered email id only to those candidates who have successfully filled the Application form and deposited the requisite Fees. Those reaching late shall not be entertained.

Candidates must bring ALL original mark sheets, degrees, testimonials, DOB certificates, caste certificate (if applicable), experience certificate and self ATTESTED photocopies of each document along with Aadhaar card (any Govt. approved photo id) and one passport size photo on the day of document verification).
