- 1. NIELIT will create a panel for contractual deployment. Data Entry Operator will be selected for deployment on contract from the panel as and when required. The selected resource person from the panel will be deployed initially for the period of six months (which may be further extended based on requirements/performance of the candidate) or upto NIELIT's contract period with the client whichever is earlier. **NIELIT does not guarantee to deploy all shortlisted candidates from panel.**
- 2. Applicants are required to go through the Eligibility criteria carefully and ascertain themselves regarding their eligibility before visiting.
- 3. The typing test and document verification will be held on the same date. Applicants must bring all the **original documents**, **self-Attested photocopies** of Marksheets/degrees/testimonials/post qualification experience certificates (including the Experience letter of the current place of working), Valid photo ID on the day of the typing test, otherwise they will not be allowed to appear in the typing test. Cut-off date for calculating experience will be **30-06-2022**.
- 4. Only those candidates, who clear the typing test will appear for Document Verification on the same day. Only those candidates who clear both typing test and document verification will be empanelled.

Applicants are required to submit the filled registration form along with the documents on the day of typing test and document verification between 9:00 AM to 10:00 AM at National Institute of Electronics and Information Technology, 2nd Floor, Parsvnath Metro Mall, Near Inderlok Metro Station, New Delhi, Delhi-110052. After registration, the candidates may appear for the typing test.

- 8. Name of the Applicant in application form must be same as mentioned in the certificate of class X. In case the candidate has changed his name subsequent to X, the evidence to that effect should be furnished at the time of typing test.
