Terms & Conditions:

1. NIELIT will create a panel for contractual deployment. **IT resource persons** (System Analyst, Programmer and Programmer Assistant 'B') will be selected for deployment on contract from the panel as and when required. The selected resource person from the panel will be deployed initially upto **27th June 2022** only or upto NIELIT's contract period with the client whichever is earlier. NIELIT does not guarantee to deploy all shortlisted candidates from panel.
2. Applicants are required to go through the Eligibility criteria carefully and ascertain themselves regarding their eligibility before visiting.
3. The interview and document verification will be held on the same date. Applicants must bring all the **original documents, self-Attested photocopies** of Marksheets/degrees/testimonials/post qualification experience certificates (including the Experience letter of the current place of working), Valid photo ID on the day of the interview, otherwise they will not be allowed to appear in the interview. Cut-off date for calculating experience will be **31-01-2022**.
4. Only those candidates, who are shortlisted after the Interview and clear the Document Verification, will be selected for empanelment.
5. Applicants are required to submit the filled registration form along with the documents on the day of interview between 9:00 AM to 12:00 PM at National Institute of Electronics and Information Technology, 2nd Floor, Parsvnath Metro Mall, Near Inderlok Metro Station, New Delhi, Delhi-110052. After registration, the candidates may appear for the interview.
6. The qualification of the candidates must be from recognized University/Institution.
7. Applicants with last semester result awaited or incomplete degrees are not eligible to apply.
8. Name of the Applicant in application form must be same as mentioned in the certificate of class X. In case the candidate has changed his name subsequent to X, the evidence to that effect should be furnished at the time of interview.
