Terms & Conditions:

- 1. Applicants are required to apply online for the position of Data Entry Operator from 28.02-2022 upto 03.03.2022 through the website http://nielit.gov.in/delhi (under Recruitment section). No other mode of application will be accepted in any case.
- 2. The interested applicants are advised to go through the eligibility criteria carefully and ascertain themselves regarding their eligibility. The same is available at http://nielit.gov.in/delhi.
- 3. The application fees of ₹ 600/- shall be charged from General/OBC category and ₹300/- from SC/ST/PWD/Women category through online mode only. Application Fee once paid is non-refundable and non-transferable in any case. Fee through any other mode like DD, Pay order, Cheque, Challan, etc. will not be accepted.
- 4. Successful submission of application will be considered only after payment of prescribed fees. NIELIT shall not be responsible for any broken transaction during online payment process. Those candidates, whose application is successfully submitted, will be called for the Typing Test. Only those candidates, who are shortlisted after the Typing Test will be called for Document Verification on separate date. The candidates who clears both Typing Test and the Document Verification, will be empanelled as Data Entry Operator. The candidates may have to appear in Typing Test more than one time as per requirement on one or different days.
- 5. Date of Typing Test and Document verification will be informed after last date of submission of form. Document verification will be done of only those candidates who qualify Typing Test. The result will be published at http://nielit.gov.in/delhi. Candidates are advised to check the website regularly. Typing Tests and Document Verification will be conducted at NIELIT Centre, Delhi only. If there is any change in location, same will be informed.
- 6. The shortlisted candidates will be empanelled for deployment on projects in specific Govt. Depts./NIELIT Delhi centre **in Delhi/NCR** purely on contract basis based on requirement/performance of the candidate from departments, initially for the period of six months (which may be further extended based on requirements/performance of the candidate) or upto NIELIT's contract period with the client whichever is earlier. *NIELIT does not guarantee to deploy all shortlisted candidates from panel.*
- 7. Final selection of candidates for hiring will be based on the performance of the candidates in the Typing Test and as found eligible as per prescribed criteria. **NIELIT** reserves right to conduct written test or skill test for screening the candidate at any time during the process of empanelment, if felt necessary.
