All interested Firms/Agencies, who have the adequate capability and proven record to conduct Computer Based Test/Exams as per the parameters mentioned in Annexure – 'A' and are desirous of entering into contract with the NIELIT Patna for conduct of such Tests/Exams are requested to send their expression of interest along with Financial and Technical details indicating their capabilities of conducting Computer Based Recruitment Test/Exam based on the parameters mentioned in Annexure – 'A'. They are also requested to submit documentary proof of having such experience along with copies of the latest work orders executed by them, during the last few years, preferably for Government Agencies/offices.

The response of the interested Agencies/Firms to this 'Expression of Interest' must reach to the NIELIT Patna latest by **02/09/2016**. ## BROAD ACTIVITIES REQUIRED TO BE CARRIED OUT BY THE AGENCY

- 1. Computer Based Tests/Examination with varying candidature up to around 5600 distributed over Centres as decided by the NIELIT Patna Centre.
- 2. The Agency will have to ensure fool-proof data security and data transfer, in the encrypted form, including physical security inside the Test/Exam venues.
- 3. Providing fail safe secured and isolated LAN for conduct of Test/Exam at each venue.
- 4. The Question Paper/Q-Pack would be generated by the NIELIT Patna Centre independently. However, complete training and software required to generate Q-Pack will have to be installed at the NIELIT Patna Centre premises. The Q-Pack will have to be encrypted and password protected at various levels which will be shared by the NIELIT Patna Centre a few minutes before conduct of Test/Exam.
- 5. The Agency will have to create Control Room at NIELIT Patna Centre premises for monitoring and supervising Test/Exam activities at all the venues.
- 6. The Agency will have to make transfer the complete Response Data along with readable form of "LOGFILES" to the NIELIT Patna Centre under secured environment immediately after conduct of the CBRT.
- 7. The Agency will have to generate various reports as per the requirement of the NIELIT Patna Centre and would help the NIELIT Patna Centre in respect of RTI queries from time to time.
