

## MEMORANDUM OF UNDERSTANDING

### ON CO-OPERATION BETWEEN

National Institute of Electronics & Information Technology, J & K, New University Campus, University of Jammu, Dr. B. R. Ambedkar Road, Jammu (hereafter called NIELIT) is an autonomous scientific society, under Ministry of Electronics & Information Technology (MeitY), Government of India

and

Indian Institute of Technology Jammu (hereafter called IIT Jammu), wish to conclude this Memorandum of Understanding (hereafter called "MoU") to establish academic, network and research co-operation in general and to co-operate on the activities set forth in this MoU.

#### A) The Objective

1. The objective of this co-operation is to foster collaboration, provide opportunity for global experience and to facilitate the advancement of knowledge on the basis of reciprocity, best effort, mutual benefit and frequent interactions.
2. IIT Jammu and NIELIT agree to explore the possibility of engaging in the following areas of collaboration:
  - Exchange of intellectual know how and resources.
  - Partnership in innovation and entrepreneurship driven opportunities and resources so as to launch the skill oriented, tailor made courses in line with Govt. of India's vision of Skill India, Digital India and Make in India.
  - Partnership of collaborative consulting and research projects.
  - Sharing of Network and Infrastructure resources

#### B) General

This MoU may only be amended or modified by a written agreement signed by the representatives of each party. The parties may disclose certain confidential information to the other in relation to any future proposal made under this MoU. Each party therefore agrees that the contents of this MoU and the negotiations in relation to any future proposal remain strictly confidential and each party hereby



undertakes not to disclose the same to any third party, save for its professional advisers, without the prior written content of the other party except where such disclosure is required by law (including without limitation, under applicable freedom of information legislation). Should there be a dispute relating to any aspect of academic cooperation the Executive Director of NIELIT J & K and the Director of IIT Jammu, his/her nominee will jointly resolve the dispute in a spirit of independence, mutual respect, and shared responsibility.
