- 03. You must submit earnest money of Rs. 10,000/- (Two thousands only) in the form of demand draft in favour of Director-In-Charge, NIELIT Ajmer Centre payable at Kekri along with the quotation which will be returned immediately to all except the vendor selected for supply. The amount will remain with this Centre as Security Deposit during the period of empanelment. In case the tenderer(s) fail to abide by the conditions of contract, adhere to the scheduled dates, the amount of EMD will be forfeited.
