

OFFICE MEMORANDUM

Department of Electronics and Information Technology (DeitY) has assigned the responsibility of conducting certification / assessment examinations for various training programmes being implemented by DeitY under several skill development and e-literacy initiatives including Digital Saksharta Abhiyan for which it is mandatory for all the beneficiaries to have the Aadhaar Number to ensure unique registration of candidates. However, it has been observed that the percentage of Aadhaar Numbers generated in NPR States/UTs is relatively low resulting in hampering the speedy implementation of the schemes of national importance. In order to ensure speedy implementation of the schemes, NIELIT has entered into a Memorandum of Understanding with Unique Identification Authority of India (UIDAI), where under it has been agreed that NIELIT shall function as Registrar for allotment of Aadhaar Numbers to various candidates, who could not obtain Aadhaar Number.

In connection with the above, Shri Sanjeev Sood, Joint Director (Tech.), NIELIT Delhi Centre is hereby nominated as **Nodal Officer** for Registrar (i.e. NIELIT) for implementation of PAN India UIDAI Project. Shri Sood will work in coordination with Regional Level Nodal Officers for Registrar, NIELIT; Joint Working Groups formed at Central and / or Regional level and UIDAI to execute the project. Shri Sood will be required to take up the proceedings related to Registrar on-boarding and implementation of UIDAI Project. He will also carry out the duties and responsibilities as conveyed to him by Addl. Director (IT) and concerned officer of NIELIT related to the said schemes from time to time.
