**कार्यालय आदेश सं.32/OFFICE ORDER No.32**

In pursuance of the directions of the Hon'ble Supreme Court of India Judgement dated 08.05.2009 in Civil Appeal No.887/2009, to prohibit, prevent and eliminate the scourge of ragging including any conduct by any student or students whether by words spoken or written or by an act which has the effect of teasing, treating or handling with rudeness a fresher or any other student, or indulging in rowdy or undisciplined activities by any student or students which causes or is likely to cause annoyance, hardship or psychological harm or to raise fear or apprehension thereof in any fresher or any other student or asking any student to do any act which such student will not in the ordinary course do and which has the effect of causing or generating a sense of shame, or torment or embarrassment so as to adversely affect the physique or psyche of such fresher or any other student, with or without an intent to derive a sadistic pleasure or showing off power, authority or superiority by a student over any fresher or any other student, in all higher education institutions in the country, and thereby, to provide for the healthy development, physically and psychologically, of all students, the All India Council for Technical Education,(AICTE) brought forth a regulation "All India Council for Technical Education (Prevention and Prohibition of Ragging in Technical Institutions, Universities including Deemed to be Universities imparting technical education) Regulations 2009" vide F.No.37-3/Legal/AICTE/2009 dated 01.07.2019.

2. In order to curb the menace of ragging at the Centre, the Competent Authority has constituted a Committee with the following members:

3. It shall be the duty of the Anti-Ragging Committee to ensure compliance with the provisions of these Regulations as well as the provisions of any law for the time being in force concerning ragging; and also to monitor and oversee the performance of the Anti-Ragging Squad in prevention of ragging in the institution. The Committee with the help of Anti-ragging Squad shall make surprise raids on hostels, and other places vulnerable to incidents and having the potential for ragging and shall be empowered to inspect such places.

- 3.1 Anti-ragging squad will be constituted the Dean (Academic) from time to time with the participation of various members of campus community.
- 3.2 It will be the duty of Anti-Ragging Squad to conduct an on-the-spot enquiry into any incidents of ragging referred to it by the Head of the institution or any member of the faculty or any member of the staff or any student or any parent or guardian or any employee of a service provider or by any other person, as the case may be; and the enquiry report along with recommendations shall be submitted to the Anti-Ragging Committee for action. Provided that the Anti-Ragging Squad shall conduct such enquiry observing a fair and transparent procedure and the principles of natural justice and after giving adequate opportunity to the student or students accused of ragging and other witnesses to place before it the facts, documents and views concerning the incidents of ragging, and considerations such other relevant information as may be required.
4. The committee will ensure proper awareness of the "All India Council for Technical Education (Prevention and Prohibition of Ragging in Technical Institutions, Universities including Deemed to be Universities imparting technical education) Regulations 2009" among students of Centre.
5. The committee will meet periodically during the admission period and oversee the entire process and suggest measures required for the prevention of ragging.
6. The committee will verify the veracity of complaints regarding ragging in the campus and institute an enquiry into the incident through Anti-Ragging Squad, initially and their finding should be further investigated and report on the same shall be submitted to the Head of Centre.
7. The committee will initiate action to spread the message of anti-ragging among the student community through orientation/awareness programme.
8. In the event of any occurrence of ragging, the matter need to be invariably reported upon and a First Information Report (FIR) must be filed without exception.
9. The committee will recommend appropriate decision on punishment need to impose up on those who found guilty of ragging. The appeal on such punishment will be also be dealt by the Committee.
10. This will come into force with immediate effect.
