4. Course Structure & Learning Outcomes: Evaluate the structure of courses, including credit distribution, instructional hours, and assessment methodologies. Review and validate Course Outcomes (COs), Programme Outcomes (POs), and their mapping.

5. Periodic Updating of Curriculum: Recommend modifications to existing courses based on technological advancements, industry feedback, and academic requirements. Oversee the introduction of new courses/programmes in emerging technology areas.

6. Quality Assurance in Academic Delivery: Provide guidance on effective teaching-learning practices and evaluation strategies. Review academic feedback from students, faculty, and industry to ensure continuous quality improvement.
