- iv. Dissemination of information on the various quality parameters of higher education;
- v. Organization of inter and intra institutional workshops, seminars on quality related themes and promotion of quality circles;
- vi. Documentation of the various programmes/activities of the College, leading to quality improvement;
- vii. Acting as a nodal agency of the college for coordinating quality-related activities, including adoption and dissemination of good practices
- viii. Development and maintenance of institutional database through MIS for the purpose of maintaining / enhancing the institutional quality;
- ix. Development of the Annual Quality Assurance Report (AQAR) of the College based on the quality parameters/assessment criteria developed by the relevant quality assurance body (like NAAC, NBA, AB) in the prescribed format;
- x. Bi-annual development of Quality Radars (QRs) and Ranking of Integral Units of Colleges based on the AQAR.

4. The Cell will start functioning with immediate effect. The Cell will meet a minimum of two times in an academic year. Reports of the proceedings must be sent to the Centre's Sub Academic Advisory Committee of the Centre.
