Sir,

Please refer to your letters No.1(68)/2015-NIELIT/3207 dated 26.12.2016 and 1(68)/2016-NIELIT/12 dated 03.01.2017 respectively.

- 2. . The AWR format, PART-A contains the self appraisal report which will be assessed by the Reporting Authority in PART-B of the AWR. The quantified S&T output indicators are provided in the Annexure of the AWR format. The reporting officer while evaluating the self appraisal report shall give appropriate numerical grading from any of the Sub-Categories of the Product Links filled by the officer reported upon for review promotion under the policy. The Reporting Officer shall also ensure that the numerical grading is accorded as per provisions of Annexure-II of the MeitY's policy.
- As regards non-availability of reporting / reviewing officers due to retirement / demission of office, since AWRs are mandatory for review promotion of the Group 'A' S&T officers, MeitY has obtained the previous AWRs whose reporting officers has / demitted the office by getting the AWRs reported by the current Reporting Authority. However, from the 2015 onwards AWRs are being obtained annually.

In order to complete the backlog promotion expeditiously, as per practice adopted in MeitY, it is advised to assess the candidates as per the old AWR format in case the AWRs have already been submitted / competed. However, fresh AWRs shall be evaluated as per the provisions of the existing policy of MeitY.
