- According to OM no. 1(18)/2017-NIELIT367, dated 16.2.2017, the terms of reference of the committee was to examine whether the period of leave beyond 180 days and leave on medical grounds, EOL etc., availed on personal grounds shall be counted towards minimum residency period under PoP Scheme.
- The Committee met on 22.02.2017 and deliberated in details on the issues related to leave matters. Based on the recommendations of the Committee, the following is approved by the Competent Authority:
 - a. The period spent on lien/deputation /Foreign Service to another organization shall be counted as residency period since the employee perform the duties and responsibilities and gains experience.
 - b. Period of Study Leave shall be counted as residency period.
 - c. Maternity Leave sanctioned as per Leave Rules shall be treated as duty while counting the minimum residency period for promotions under PoP, leave of a maximum period of one year sanctioned in continuation of maternity leave as per Leave Rules may also be treated at par with maternity leave and this period may consequently be taken into account while counting the minimum residency period under PoP.

d." Any in leave combination beyond 180 (earned type any days leave/Commuted/HPL/CCL/EoL) beyond 180 days in a particular year (either on one count or in the different spells) should not be taken into account for counting of residency period. In that event the whole year shall not be counted as residency period.
