OFFICE ORDER

With reference to his technical resignation, the Competent Authority has accepted the request of Sh B. N. Choudhury, Addl. Director (P&A)/ Director-in-charge, NIELIT Bhubaneshwar Centre w.e.f. 09/11/2017 along with condonation of notice period of 45 days out three month's period, as per his own request.

- 2. Sh Choudhury shall stand relieved from the post held by him in NIELIT upon serving notice period of 45 days, on the afternoon of Friday, 22nd December, 2017, being Saturday as 23rd December, 2017, so as to join the post of Registrar in NIT, Meghalaya for a term of five years from the date of joining or attainment of 62 years, whichever is earlier, after availing admissible joining time.
- 3. Sh Choudhury shall be eligible for joining time as per applicable Rule.
- 4. Upon his relief from NIELIT, the pay and allowances of Sh Choudhury w.e.f. 23/12/2017 shall be borne by NIT, Meghalaya.
- 5. Sh Choudhury shall retain lien on the post of Addl. Director (P&A) in NIELIT for the next two years from the date of his relieving from NIELIT, as per rule. The terminal benefits of Sh Choudhury including leave encashment, gratuity etc will be settled as and when his lien terminates on the post held in NIELIT.
- 6. Sh V. Krishnamurthy, Director-in-charge, NIELIT Tirupati Centre and Smt. Varsha Deshmukh, Administrative Officer stand transferred to NIELIT Bhubaneswar Centre with immediate effect, in public interest. All matters related to NIELIT Tirupati Centre will be handled by NIELIT Chennai Centre consequent upon the above transfer.
- 7. Sh V. Krishnamurthy will be Director-in-charge of NIELIT Bhubaneswar Centre subsequent upon relieving of Sh Choudhury. Sh Umakanta Tripathy, Asst. Director (EDP) will report to Sh Krishnamurthy and Smt Deshmukh will report to Sh Tripathy. The concerned employees will ensure proper handing over/ taking over of the charge.
