## **OFFICE MEMORANDUM**

With a view to consolidate operations and streamline management of NIELIT Centres, following decisions have been taken:

- Demerger of NIELIT Delhi Centre from NIELIT HQ and to allow for greater autonomy in managing its operations and financials.
- NIELIT East Delhi Office at Karkardoma and NIELIT West Delhi Office at Janakpuri shall function as branch offices / part of NIELIT Delhi Centre to consolidate operations and streamline management;
- iii. The accounts of these two branch offices shall be operated by Delhi Centre and all revenues and expenditure of the two branch offices shall be booked under the accounts of Delhi Centre;
- iv. The DGCA Exam activity of Delhi Centre is entrusted to NIELIT HQ. The revenue and expenditure of DGCA shall be booked under NIELIT HQ revenue and expenditure;
- v. The DGCA Exam & Software team of Delhi Centre is being retained by NIELIT HQ and shall work in co-ordination with Examination Operation Team, IT Team and Software Development team of NIELIT HQ; and
- vi. legal cases of NIELIT Delhi Centre be tracked by concerned officials of NIELIT Delhi Centre only.
