OFFICE ORDER

Shri Gordon Kynsai Nongkynrin was appointed as Scientist 'C' vide Office Order No. DOEACC/AIZ/203/17/07 dated 19.10.2010 of NIELIT Aizawl Centre with effect from 08.10.2010 on a term contract basis for a period of five years. His tenure of contract has since been further extended every six months.

In pursuance of the order dated 01.12.2022 in WP (C) No. 96 of 2022 and order dated 08.12.2023 in WP No. 23 of 2023 of the Hon'ble High Court of Meghalaya at Shillong, the matter relating to the appointment of Shri Gordon Kynsai Nongkynrin to the post of Scientist 'C' in NIELIT in a substantive/permanent capacity with effect from 08.10.2010 has been examined in consultation with Ministry of Electronics and Information Technology and the proposal has since been approved by the Chairman, Governing Council of NIELIT.
