OFFICE ORDER

With a view to improve/extend medical facilities to the employees of NIELIT and their dependent family members [post retirement or upon opting for voluntary retirement], from NIELIT's empaneled Health Care Organizations, it has been decided with the approval of the Competent Authority that all the regular employees of NIELIT, at the time of retirement/superannuation or upon opting for voluntary retirement, may be issued fresh Photo Identity Card highlighting "Retired" status [detailing the information with respect to the designation that the employee is holding at the time of retirement/voluntary retirement, Pay Level from which the employee has retired/opted voluntary retirement, Date of Birth & Date of Retirement/voluntary retirement of the employee and address] along with fresh Dependent ID Cards [in respect of the family members who are dependent on the employee at the time of retirement/voluntary retirement].

- 2. As per the terms and conditions of the Agreement entered into between NIELIT and its empaneled Health Care Organizations, all the empaneled Health Care Organizations have agreed to provide comprehensive OPD/IPD/investigative medical facilities on offer to NIELIT's staff, both working and retired and their dependent family members [as per office records], as per entitlement, at CGHS/DGHS rates/norms.
- 3. For providing ID Cards to the regular employees at the time of retirement, NIELIT will have to bear nominal charges towards printing of the Identity Cards only and the same in turn will enable the superannuated/retired employees to get the medical healthcare facilities at CGHS rates, which will be of significant financial assistance to the retired employees, especially, in the wake of the absence of any significant post-retirement medical facility/policy like CGHS Card etc., in NIELIT.
- 4. Though, issue of fresh Photo Identity Card may be free of cost, each subsequent printing of the Identity Card on demand [by the retired employee] may be chargeable @ Rs.300/- per card, on similar lines as Dependent ID Cards.
- This issues with the approval of the Competent Authority.
