
Subject: Declaration of NIELIT Lucknow Centre as an Independent Centre – reg.

With the approval of the Competent Authority, NIELIT Lucknow, an Extension Centre of NIELIT Gorakhpur, reporting to Executive Director, NIELIT Gorakhpur, will function as an Independent NIELIT Centre and report to HQ directly w.e.f. 1st January, 2023.

2. In view of the above, actions to be followed are as under:-

- (i) All Administrative Matters of Lucknow Centre shall be dealt with independently as per conduct rules, office procedures, Delegation of Powers and the extent rules applicable to NIELIT. NIELIT Lucknow shall complete all the requirements like the establishment of Executive Committee, the appointment of auditors, etc. at the earliest.
- (ii) Separate Books of Account shall be maintained by NIELIT Lucknow Centre so as to prepare annual financial statements of the Centre w.e.f. 01st April, 2022. NIELIT Gorakhpur shall provide full support to separate the accounts for NIELIT Lucknow w.e.f. 01.04.2022.
- (iii) NIELIT Gorakhpur and NIELIT Lucknow will work independently under the administrative control of NIELIT Headquarters with defined jurisdiction as per **Annexure**. The assets and liabilities of both the Centres will be divided based on the books of accounts and stores.
- (iv) For the purpose of all the interaction with/ by the Government in the State; NIELIT Lucknow will act as the Nodal Centre.

3. Dr. D.K. Mishra, Director-Incharge, NIELIT Patna is transferred from NIELIT Patna and appointed as DIC, NIELIT Lucknow till further orders, whichever is earlier. The above transfer being in public interest, Dr. Mishra will be entitled to TA/DA as per rules.


