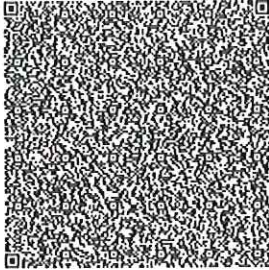

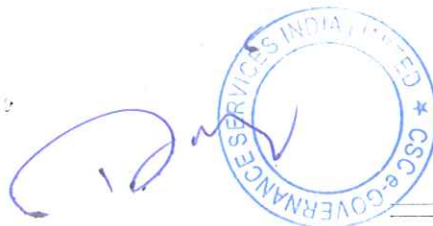

THIS MEMORANDUM OF UNDERSTANDING ("MOU") EXTENSION AGREEMENT (hereinafter referred to as the "MOU Extension") is made and entered into this *first* day of *08*/*14* year, by and between the CSC e-GOVERNANCE SERVICES INDIA LIMITED and the National Institute of Electronics and Information Technology

(NIELIT), and each agreeing to be bound by the terms and conditions of this MOU Extension. The parties agree as follows:

**1. PRIOR MOU:** The parties executed a MOU dated 01<sup>st</sup> October 2012 with terms of two years commencing on 01<sup>st</sup> October 2012 and that expired on 30<sup>th</sup> September 2014.

**2. EXTENSION OF PRIOR MOU TERM:** The parties hereby agree to extend and continue the aforementioned MOU for an additional term of **three years**, commencing on the **First day of October, 2014**. All revised and additional terms, conditions, and provisions of said MOU Extension are hereby mentioned below –

**1) Mutual Obligations:**

**A. NIELIT agrees that it shall:**

- Will provide Electricity and Space for establishment and functioning of Aadhaar Enrolment Centres by CSC-SPV at its respective NIELIT Centres/Ex-Centres.
- Will conduct Remote Proctor and non-proctor based examination for joint schemes with CSC-SPV's and other schemes as per mutual agreed terms and conditions.
- Will facilitate CSC to set up Aadhaar based verification of candidates at its Examination /Training Centres

**B. CSC-SPV agrees that it shall:**

- Will bear cost for development and maintenance of online solution of services for delivery to students, accredited institutes through CSCs.
- Will bear Desktop/laptop , equipment /devices cost for biometric enrolment , manpower and other related cost for establishing and making Aadhaar Enrolment Centres functional at all the NIELIT own Centres/Extension Centres.
- Will bear the cost for customization of the software of Student Web Portal to incorporate facilities such as linking with Aadhaar, Direct/Project/Sponsored training and making it parametric to encompass all the courses offered by NIELIT.
- Will bear the cost for technical support for integrating online application of facilitation software for facilities like payment gateway (including CSC wallet), discount policy based on multiple centres and linking centres belonging to an Institute.
- Will provide software for conducting remote proctor and non-proctor based examinations to NIELIT free of cost.
