## **Terms & Condition**

- 1. The business associate/dealer should enclose a copy of the proof of his claim in the form of a letter/certificate issued by Tally solutions to establish his/their claim as an authorized business associate.
- 2. The above quotation should be submitted in person or reach this office by 15.00 hrs on or before 16<sup>th</sup> June, 2016.
- 3. Delivery and installation to be completed within 15 days from the date of purchase order.
- 4. The supplier should provide a physical media of the software along with paper license.
- 5. The supplier should ensure proper installation of the software and obtain the satisfactory installation report from the Finance Wing of NIELIT HQ.
- **6.** Payment will be released after successful delivery, installation commissioning of the product providing training and submission of performance security.
- 7. The quotation must accompany an EMD of Rs. 6500/- in the form of DD in favour of NIELIT drawn on any nationalized bank payable at New Delhi failing which quotation may not be accepted.
- 8. The selected supplier will be required to furnish a Performance Security @10% of the total value of the Purchase Order in the form of a BG/FDR drawn on any nationalized bank in the name of NIELIT within 10 days of receipt of Purchase Order and should be valid for a period of 14(12+2) months from the date of last installation.
- 9. The Supplier will be required to provide minimum one week free of cost training to finance/stores official of NIELIT.
- 10. The quotation should remain valid for acceptance by NIELIT for a period of 90 days from the date of opening. DG, NIELIT reserves the right to reject any or all the quotations without assigning any reason thereof.

- 11. EMD of the unsuccessful bidders shall be refunded after award of P.O. to the successful bidder and EMD of the successful bidder shall be refunded after submission of the Performance Security.
- 12. There should be min. 12 months warranty on the supplied product. During period of warranty all patches and updates should be provided free of cost to NIELIT.
- 13. Taxes shall be paid extra as applicable.
