- The Remuneration mentioned above is consolidated salary. The selected candidate will not be paid any other financial benefits like Medical, HRA, Transport etc. except the consolidated salary.
- 3. The qualification of the candidates must be from recognized University/Institution.
- 4. The candidate must appear for document verification and Walk-in-Interview on the given date in the given time (as published in advertisement) only. Those reaching late shall not be entertained.
- 5. Only those candidates, who clear document verification, will stay for Walk-in-Interview. Others may leave the venue. Interview and document verification will be held on the same day.
- 6.
