MEMORANDUM OF UNDERSTANDING (MOU)

This Memorandum of Understanding (MoU) is made and entered into on $23^{\rm rd}$ day of May 2022 by and between:

The Indira Gandhi National Tribal University (IGNTU), Amarkantak, established by an Act of the Parliament of India. It came into existence by the Indira Gandhi National Tribal University Act, 2007 and came into action on July 2008. The jurisdiction of the University extends to the whole country and it is fully funded by the Central Government through the University Grant Commission. Herein after referred as IGNTU which expression shall where the context so admits or implies include its heirs, executors successors and permitted assignees.

National Institute of Electronics & Information Technology (NIELIT) having its registered office at Electronics Niketan, 6, CGO Complex, Lodhi Road, New Delhi, an Autonomous Scientific Society of Ministry of Electronics & Information Technology (MeitY), Government of India, New Delhi hereinafter referred as NIELIT which

WHEREAS the objectives of NIELIT are as follows:

- 1. To generate quality manpower and develop skilled professionals in the area of Information, Electronics and Communications Technology (IECT) and allied, by providing world class education & training and accreditation services;
- 2. To provide continuing support to learners and trainers through active design & development of innovative curricula and acquisition of content, aligned with the dynamically changing IECT;
- 3. To establish a quality system of examination and certification that is globally recognized providing a fair assessment of the competency of students;
- 4. To continue to implement the DOEACC Scheme for computer courses, jointly developed by AICTE and DIT (now MeitY) in the non-formal sector of IT Education and Training;
- 5. To establish standards in the areas of IECT and to develop markets in the emerging areas;
- 6. To impart continuing Education for up-gradation of knowledge and skills in view of high obsolescence in the area of IECT;
- 7. To provide entrepreneurship development programme in the area of IECT;
- 8. To develop and promote the culture of a market to encourage and nurture industryoriented design and development;
- 9. To purchase, lease, hire, exchange or otherwise require any immovable property and the sell, lease, dispose off, exchange, invest and deal with bonds, moneys, securities and all kinds of movable or immovable properties for all or any of the objectives for which the Society is established;
- 10. To levy and receive moneys in connection with the activities of the Society including grants/ loans as and when received from the Government or from any other sources;
- 11. To do all such activities which are incidental/ ancillary for achieving the objectives of the Society.

WHEREAS the objectives and functions of IGNTU are as follows:

1. To provide avenues of education, especially higher education and research facilities primarily for the tribal population of India.

- 2. To disseminate and advance knowledge by providing instructional and research facilities in tribal art, tradition, culture, language, medicinal systems, customs, forest based economic activities, flora, fauna and advancement in technologies relating to the natural resources of the tribal areas.
- 3. To collaborate with national and international universities and organizations, especially for undertaking cultural studies and research on tribal communities.
- 4. To formulate tribal centric development models, publish reports and monographs and to organize conferences and seminars on issues relating to tribes and to provide inputs to policy matters in different spheres.
- 5. To take appropriate measures for promoting the members of tribal communities capable of managing, administering and looking after their own needs by access to higher education through a university of their own.
- 6. To disseminate and advance knowledge by providing instructional and research facilities in such other branches of learning as it may deem fit.
- 7. To take appropriate measures for promoting innovations in teaching learning process in inter-disciplinary studies and researches and to pay special attention to the improvement of social, educational and economic conditions and welfare of the scheduled tribes within the Union of India.

PREAMBLE:

The globalization and drive to competitiveness is making the educational institutions to focus on their core professional competencies and academic interaction with the Universities and other educational institutional authorities and such government bodies for development of specialized talented and skilled technical students. Though the importance of technical education is unquestionable, fostering a carrier today in technical field requires more than just formal education or such academic qualification.

Therefore, the NIELIT has decided to introduce and implement such technical long term courses which would not only provide the technical skill and ability but also bridge the gap between the academic and industry requirement by providing industry specific quality education / training at an affordable cost, thereby updating and generating quality manpower and skilled professionals in IECT and allied fields according to the needs of the industry.

AIMS & OBJECTIVES:

The IGNTU and NIELIT foresee that there is a vast scope of upcoming technical innovations as there is continuous progress in industrial and other allied sectors. Both parties agree to strive hard to provide all possible technical support to these sectors for upliftment of the IECT related activities of the region/country. The broad objectives of MoU are listed below.

- 1. Integration of NIELIT 'O' level course with undergraduate programme of IGNTU in line with NEP 2020.
- 2. Conduct of Internship programme for IGNTU students in NSQF aligned/ emerging technologies / future skills programmes of NIELIT.
- 3. Opening of NIELIT Centre in IGNTU Campus.
- 4. Skilling of local youth and students from every part of the Country in IT and Electronics programs of NIELIT.
- 5. Conduct of Faculty development programme for IGNTU by NIELIT.
- 6. Design and Development of joint Training programme and joint certification by NIELIT and IGNTU.
- 7. Providing access to Industry/ Job market to IGNTU and NIELIT students in Electronics and IT areas
- 8. Submission of joint R&D project to Government and Non-Government organizations to seek funding support.
- 9. Access to IGNTU faculty to join NIELIT educational programmes running in different centres across the country.
- 10. Access of NIELIT Virtual Academy of NIELIT to IGNTU students
- 11. Any other joint collaborative activities envisaged from time to time.

DUTIES AND RESPONSIBILITIES OF IGNTU:

- 1. To provide suitable built up space free of cost to NIELIT to start initial activities.
- To provide 1 to 3 acre of land for construction of permanent campus of NIELIT in IGNTU Campus.
- 3. To provide accommodation to NIELIT Officers / Faculties as per the University norms, till the Permanent Campus of NIELIT Comes up, on the allotted land as per the availability.
- 4. To provide internet Node at NIELIT premises.

- 5. The IGNTU shall arrange for the award of Degrees/ Diplomas/ Certificates to the candidates of the NIELIT Centre on the basis of the recommendations made by the NIELIT as per the internal evaluation of the NIELIT.
- 6. The IGNTU recognizes NIELIT as an autonomous institution. The IGNTU shall continue to recognize NIELIT as an autonomous institution with its own and independent evaluation system and curriculum structure for the purpose of awarding degrees/diplomas/certificates on the basis of the internal evaluation and recommendation of NIELIT.
- 7. The IGNTU shall extend to NIELIT the use of facilities of laboratory, library, and other facilities available at the university on mutual agreeable basis.
- 8. The IGNTU shall provide such other certificates as it feels necessary and appropriate as per the rules & regulations of the IGNTU.

DUTIES AND RESPONSIBILITIES OF NIELIT:

- 1. To station faculties and staff to run the activities of NIELIT.
- 2. To furnish the built up space with required furnitures, Computers, LAN and any other basic amenities for smoothly conduct the activities of NIELIT.
- 3. NIELIT will pay the Electricity Bills consumed for its activities to IGNTU
- 4. NIELIT shall conduct formal courses (full time / part time etc.) related to IECT and allied fields at its campus.
- 5. NIELIT shall undertake the design and development of course structure, syllabus, eligibility for admission, training, engagement of faculty / staff, stipend to students, budgetary expenditure, equipments and laboratory, infrastructure, conduct of terminal examinations, sessional work, assessment procedure, continuation of studies, break in studies, award of divisions etc.
- 6. NIELIT shall obtain regular approval of concerned authorities like AICTE etc. for conducting the formal courses such as Diploma, MCA, B.Tech, M.Tech etc.
- 7. NIELIT shall submit the proposal to the IGNTU/ intimate the IGNTU for Introduction of new formal courses in future.
- 8. NIELIT will provide admission to five Faculties of IGNTU per year in its M.Tech. Program running at its various centers in sponsored category.

Joint Activities:

The cooperation may concern any field or subject upon which the IGNTU and NIELIT agree. This will include various activities as mentioned below:

A. Faculty and Research Staff

It is agreed that linkages will be strengthened by IGNTU personnel visiting to NIELIT and NIELIT officials visiting to IGNTU. The purpose is to exchange scientific & technical knowledge/information and develop specific cooperative projects and programs. The timing and other details concerning the visit of the faculty shall be mutually decided and acceptable to both the parties on reasonable payment basis.

B. Students Project Work:

It is mutually agreed upon between the parties that both the parties shall allow students for study and to do project work related to their corresponding Degree/ Post Graduate Degree on mutual consent some concrete operational details and other modalities such as the number of students, the periodicity etc.

C. Short Term Courses Training

The IGNTU and NIELIT agree that there are considerable benefits in providing opportunities to the students in the form of Short Term Courses to update their knowledge and skill. Arrangements to this end shall be considered on a case-to-case basis as per the recommendations from both side.

4. Academic Information and Publications.

The IGNTU and NIELIT has agreed that

- a) Scientific publications and journals, university calendars, prospectuses, text books, course outlines and reference materials are useful for the students. Therefore, the students of the IGNTU and NIELIT shall use them for developing and strengthening their technical knowledge and ability.
- b) Work together in matters relating to making training and education relevant to the changing technological scenario including design, development, implementation and review of curricula and resource materials.
- c) Co-operate in the development of faculty of NIELIT to make the faculty, technical education and training system dynamic, self generating and forward looking.
- d) Share experience and expertise in planning, training and development of right kind of technical manpower in the region.
- e) Jointly work on the R&D and consultancy projects, job work etc.

f) Organise joint workshops/seminars of national / international level in the field of IECT education of mutual interest including the IT awareness and opportunity workshops.

SCOPE OF THE MOU

- 1. The IGNTU and NIELIT are pleased to enter into this Memorandum of Understanding and strongly believe that such an understanding would lead to a continuing period of meaningful interaction, cooperation and exchange of information and ideas for mutual benefit and benefit of the people of India.
- 2. The IGNTU and NIELIT value the spirit of this MoU and could spare no efforts to continuously strengthen and develop the various clauses of this MoU.
- 3. This MoU shall be extended for such period and on such further understanding as may be deemed necessary from time to time.
- 4. Draw the attention of top management in case of any interface or operational problems.
- 5. Mutual academic and other issues shall be discussed through JCC consisting three members from IGNTU & three members from NIELIT. Senior most Professor of the IGNTU will chair the meeting.

ARBITRATION & JURISDICTION

- 1. Both the IGNTU and NIELIT agree that provisions content in this MoU do not create any legal obligations between the parties.
- 2. In the event of any misunderstanding and differences between the parties hereto, such misunderstanding / differences shall be resolved amicably by mutual discussions.
- 3. It is hereby agreed between the parties that if any dispute arose between the parties which would not be resolved with mutual consent, in that case, the matter / dispute shall be referred to an Arbitrator who shall be appointed with mutual consent.

Signature of the Memorandum of Understanding (MoU)

This Memorandum of Understanding (MoU) is entered into at IGNTU, Amarkantak (Madhya Pradesh) on this day of 23rd May 2022.

This MoU has been executed in two originals. One of these has been retained by the NIELIT and the other by IGNTU.
