NOTIFICATION

Subject: Revision in the Accreditation Structure of O/A/B/C Level (IT) Courses

NIELIT grants accreditation to the institutions in the public and private sectors for conducting O/A/B/C Level IT Courses, subject to their meeting prescribed norms and criteria, in line with erstwhile DOEACC Scheme in practice since 1994. Over the period of time, considering the demand and present market scenario, the advancements have been incorporated in the process of grant of accreditation to the institutes. The advancement are as follows:

1. The Provisional Accreditation for NIELIT O/A/B/C level of courses will be granted for a period of 5 years and the Accreditation fees for NIELIT O/A/B/C level of courses, will be Rs. 50,000/- + GST (as applicable) + Security Deposit (refundable as per norms) of Rs. 10,000/-.
2. Institute can apply online along with all the required documents for Provisional Accreditation at the online portal for accreditation. However, **Institute will be granted accreditation for NIELIT 'O' level course on the basis of self-certification**, with respect to availability of the infrastructure, as per norms and approval of competent authority.
3. Random yearly Monitoring visits will be conducted at the institutes.
4. **There will be no change in the accreditation process for NIELIT A, B and C level of courses.**
5. The institutes whose application for grant of Provisional Accreditation for NIELIT O level course is under process will be intimated the transition process accordingly by email and has to submit the following fees/documents through the portal from the Login of the institute.
 - i. Balance fee of Rs. 20,000/ along with GST (as applicable), using the Payment Gateway.
 - ii. The Geo locations / coordinates (longitude, latitude) of the location of the institute and also provide the website address of the institute and the documents of faculty, premises (electricity bill/ water bill etc. / layout map and photograph [latest coloured photographs (with the time stamp) of the Class room, Computer Lab, Library, Reception, washroom, front view (Entrance) of the institute and its surroundings (in single pdf file). The institutes also have to send the walkthrough video (size upto 25MB) of the institute through email id "accr-docs@nielit.gov.in".
 - iii. Updating of software and hardware as per the 5th revised syllabus of NIELIT O and A level course.

- iv. An Affidavit on the Rs.100/- Non-Judicial Paper Duly Attested by Notary Public, signed by authorized signatory of the institute that the information/documents provided by the institute w.r.t. legal status/address/infrastructure /faculty/Financial status etc. for grant of NIELIT O/A//B/C level accreditation are true and correct and that it conceals nothing and that no part of this is false. **(Format will be made available to the institutes through link available on the NIELIT website and through email also.)**
- v. All the documents and balance fees can be submitted by the institutes, who have already applied for 'O' level accreditation upto **31st March 2023**. Further in case of any query, institutes may contact NIELIT at accr@nielit.gov.in/accr1@nielit.gov.in or at 011-25308351. No query in this regard will be entertained after 31st March 2023.
