All institutes accredited for various NIELIT courses are hereby informed that new accreditation Portal for NIELIT DLC, O/A/B/C has been made live for fresh applications as well as Renewal.

- complete their migration from existing portal(s) to new accreditation software at <https://accreditation.nielit.gov.in/> by 31/03/2026
 - W.e.f 14/10/2025 onwards **Renewal of Facilitation Centre for conducting Digital Literacy Courses (DLC) will be done in online mode.** The address for online portal for applying for Renewal of DLC is <https://accreditation.nielit.gov.in/>. All facilitation centres are hereby advised to apply for renewal through the said portal. Further the **payment of processing fee for renewal / change to be made through accreditation portal only.** Payment made through any other mode will not be settled / refunded.
 - Fees for change of premises and franchisee for NSQF courses has been revised to Rs. 20,000/-. The institutes will be required to pay revised fee for change of various parameters, as detailed in the table below –

NOTE : Incase of Institutes accredited for more than one NIELIT course, the fee payable for updating institute details shall correspond to the highest applicable fee across those courses.

- Pending applications through previous portals that are unprocessed to date, are granted a one-time opportunity to re-apply through the new accreditation portal against fee previously paid vide previous Reference Numbers. Institutes that fail to re-apply by 31/12/2025 shall have their earlier applications summarily rejected. No further requests for consideration shall be entertained by NIELIT under any circumstances.
