

This Memorandum of Understanding ("MOU") is made the 17 July 2025 ("Effective Date")

BETWEEN

ARM LIMITED whose registered office is at 110 Fulbourn Road, Cambridge, CB1 9NJ, UK ("Arm")

and

NATIONAL INSTITUTE OF ELECTRONICS AND INFORMATION TECHNOLOGY (NIELIT) whose registered office is at NIELIT Bhawan, Plot No. 3, PSP Pocket, Sector-8, Dwarka, New Delhi, Delhi, 110077, India ("Partner")

(individually a "party" and collectively the "parties")

BACKGROUND

ARM and Partner wish to engage with one another in order to cooperate on education, research and skills development, globally, in Computer Engineering and Informatics (CEI) subjects, and Science, Technology, Engineering and Mathematics ("STEM") more broadly.

PURPOSE

1. The purpose of this MOU is to record the mutual interest of Arm and Partner in promoting and furthering a strategic relationship which will promote communities of practice in CEI and STEM education and research, involving industry partners, academia and the third sector.
2. The parties may undertake specific projects from time to time, subject to the negotiation and finalisation of appropriate separate contractual terms.
3. The parties intend to form an alliance to cooperate and combine resources for the purpose of plugging the education, research and skills gap in CEI and STEM, through the effective use of foundational technologies from Arm and its partners ("Education Alliance").
4. As an Education Alliance member, Partner will, at its sole discretion, collaborate with Arm, other Education Alliance members and/or broader ecosystem partners to:
 - (i) combine courses and programs on online learning platforms to create richer, threaded learning journeys;
 - (ii) leverage shared assets to create new sets of differentiated content, including making available existing and repurposed/modified educational materials and assets for use in new formats or on new platforms;
 - (iii) develop learning pathways, leading to recognised qualifications in support of ecosystem talent needs;
 - (iv) explore and implement co-marketing and promotional opportunities in education and academia;
 - (v) contribute to existing and emerging communities of practice and their respective platforms, including jointly creating curricula, standards or learning pathway frameworks and building momentum around platforms that foster the communities and the frameworks;
 - (vi) leverage expertise and influence by providing thought leadership, technical expertise and support, including supporting the creation of new resources of mutual interest;
 - (vii) Join efforts to influence governmental and non-governmental organizations in support of CEI and STEM education, research, and skills
5. Education Alliance members will benefit from:
 - (i) an accelerated technical marketing roadmap based on foundational content and assets from Arm and ecosystem;
 - (ii) accelerated pace towards scalable learning pathways or programs for education, academia and professional developers; and

- (iii) better provisions for talent acquisition and learning and development teams.

PUBLIC STATEMENTS AND USE OF ARM AND PARTNER TRADEMARKS

This section is legally binding.

6. The parties acknowledge the merits of positive publicity and Arm shall have the right to disclose that Partner is a partner of Arm. Arm may use Partner's logo for identification of Partner as part of the Education Alliance on Arm's website and in the Education Alliance promotional slide deck and presentation. For all other use of Partner's logo Partner shall prior review and approve (which may be by email) all promotional and marketing material with Partner logos.
7. Partner may use Arm's name and logo for the marketing and promotion of the activities contemplated by this MOU, provided that: (i) any use of Arm's name and/or logo shall be subject to Arm's prior review and written approval (which may be provided by email); and (ii) Partner shall at all times comply with Arm's trade mark usage guidelines available at <http://www.arm.com/about/trademarks/index.php> (as may be updated) and any additional guidelines that Arm may supply from time to time.
8. Any formal public announcement or press release in relation to the activities contemplated by this MOU shall be discussed by the parties and must be mutually agreed upon prior to any publication.

INFORMATION SHARING

This section is legally binding.

9. Confidential information will not be shared under this Agreement.
10. Any materials shared are provided "as is". Neither party makes any warranties, express or implied, concerning the accuracy or completeness of its materials. The disclosing party accepts no responsibility for any expenses, losses or action incurred or undertaken by the recipient as a result of the recipient's receipt or use of the materials.

TERM AND TERMINATION

This section is legally binding.

11. This MOU shall commence on the Effective Date and shall continue in full force and effect unless terminated in accordance with the provisions of Clause 12.
12. Either party may terminate this MOU at any time, with or without cause, effective immediately upon written notice of termination.

EFFECT OF THIS MOU

This section is legally binding.

13. While the parties wish by this MOU to make clear their support of, and enthusiasm for, the purposes outlined above, this MOU, other than where expressly stated otherwise, is not intended to create any legally binding relationship between the parties. The parties recognise that any agreement or agreements involving the parties which may subsequently be negotiated will, prior to execution, require the express approval of specific bodies and duly authorised officers within the parties, and they acknowledge that at any time in advance of such execution the parties and each of them shall be free to propose arrangements different from those outlined in this MOU or unilaterally to cease any consideration or negotiation contemplated by this MOU without any liability whatsoever to the other party.
14. The provisions of Clauses 9-14 of this MOU shall survive.
