MINUTES OF THE 14th MEETING OF NATIONAL SKILLS QUALIFICATIONS COMMITTEE (NSQC) OF NCVET HELD ON 30th DECEMBER, 2021

- 1. The 14th meeting of the National Skills Qualifications Committee (NSQC) under National Council of Vocational Education and Training (NCVET) was held on 30th December, 2021, through Video-Conferencing, under the Chairmanship of Dr Nirmaljeet Singh Kalsi, Chairperson, NCVET. The list of participants is at Annexure-I.
- 2. The decisions taken, w.r.t agenda items, in the meeting are given in the succeeding paras.

AGENDA 1: CONFIRMATION OF MINUTES OF THE 13th MEETING OF NSQC

3. The Committee **confirmed** the Minutes of the 13th meeting of NSQC held on 25th November, 2021.

AGENDA 2(A): ACTION TAKEN REPORT ON THE MINUTES OF THE 13th MEETING OF NSQC

4. The Committee was given a detailed account of the action taken on the Minutes of the 13th NSQC meeting wherein compliances on conditionally approved qualifications from various Submitting Bodies had been received and uploaded on National Qualification Register (NQR) Website. However, compliance issues of qualifications of Agriculture SSC and FICSI which were granted conditional approval are still awaited. Details are given below:-

a) Agriculture SSC:

i) "Dairy Farmer- Entrepreneur". The Committee directed that DGT should be requested to expedite submission of comments by 7th January 2022. In case no comments are received by then, it shall be presumed that DGT is in agreement and the Qualification shall be considered as approved.

b) **FICSI**:

- i) "Artisanal Cheese Maker"
- ii) "Artisanal Chocolate Maker"

CEO, FICSI was requested to expedite fulfilment of commitment on priority.

5. AGENDA 2(B): ACTION TAKEN REPORT ON THE MINUTES OF THE 12th MEETING OF NSQC

a) **FDDI**:

- i) "Training of Trainer-Footwear".
- ii) "Training of Trainer-Goods and Garments'.

The Committee requested FDDI to expedite submission of comments by 10th January 2022, post which it shall be assumed that FDDI is not keen in pursuing the Qualifications and they shall be considered as "Not Approved" and withdrawn.

b) Apparel SSC:

- i) "Storekeeper",
- ii) "Garment Cutter (CAM)", and
- iii) "Online Sample Designer".

The CEO Apparel was requested to expedite submission of compliance or submit detailed justification for not being able to commit any target for the training in all the above three mentioned courses for the NCVET to take informed decision accordingly.

6. The status of conditionally approved files with respect to compliance is at **Annexure-II**.

AGENDA 3: SUBMISSION OF QUALIFICATIONS FOR NSQF ALIGNMENT

- 7. The Committee was apprised that a total of 254 Qualifications (69 new and 185 revised) were received till 31st October, 2021. Post desk scrutiny, out of 254 Qualifications, 200 Qualifications (63 new and 137 revised) were considered for NSQF alignment. Rest of the qualifications were returned to the respective submitting bodies/ not taken up in this meeting on account of being incomplete, delay in receipt of response to the observation made or rationalization of qualifications being undertaken by the SSCs. The decision of NSQC on these 200 Qualifications is in succeeding paras.
- 8. <u>Directorate General of Training (DGT).</u> Seven (07) new qualifications presented before NSQC for NSQF Alignment and approval were approved.

- National Institute of Electronics and Information Technology (NIELIT). One
 (01) new and two (02) revised qualifications of IT sector presented before
 NSQC for NSQF Alignment and approval were approved.
- ASAP, KERALA. Two (02) revised qualifications presented before NSQC for NSQF Alignment and approval were approved.
- 11. West Bengal State Council for Vocational Training (WBSCVT). One (01) new qualification of Electronics Sector presented before NSQC for NSQF Alignment and approval was approved.
- 12. **Automotive SSC.** Six (06) new qualifications of Automotive Sector presented before NSQC for NSQF Alignment and approval were approved.
- Apparel SSC. Twenty (20) revised qualifications presented before NSQC for NSQF Alignment and approval were approved.
- 14. Agriculture SSC. Twenty-three (23) revised qualifications of Agriculture Sector were presented before NSQC for NSQF alignment and approval. The Committee approved twenty-two (22) qualifications. The Remaining one qualification namely, 'Marine Cum Deep Sea Fisher' was withdrawn by the SSC to relook the nomenclature and enlisted competencies in the Qualification File.
- 15. <u>Electronics SSC</u>: Ten (10) new qualifications presented before NSQC for NSQF Alignment and approval were approved.
- 16. Food Processing SSC (FICSI). Six (06) new and six (06) revised qualifications of Food Sector were presented before NSQC for NSQF alignment and approval. The Committee approved eleven (11) Qualifications. Remaining one qualification namely, 'Supervisor- Bakery Products' was withdrawn by the SSC to reconsider at the notional hours and level of the Qualification-
- 17. **Gems & Jewellery SSC**: Four (04) new and six (06) rationalized qualifications presented before NSQC for NSQF Alignment and approval were approved.

- 18. <u>Handicraft and Carpets SSC</u>: One (01) new and fifteen (15) revised qualifications presented before NSQC for NSQF Alignment and approval were approved.
- 19. **SSC NASSCOM**: Seven (07) new and thirteen (13) revised qualifications presented before NSQC for NSQF Alignment and approval were approved.
- 20. <u>Life Sciences SSC</u>: Two (02) rationalized and ten (10) revised qualifications were placed before the committee for NSQF alignment and approval. The NSQC approved all qualifications.
- 21. <u>Media SSC</u>: Ten (10) new qualifications of Media SSC placed before NSQC for NSQF Alignment and approval were approved.
- 22. Skill Council for Persons with Disability: One (01) new and eleven (11) revised qualifications were placed before the Committee for NSQF alignment and approval. The Committee approved all the revised Qualifications, With regard to the new qualification, the Committee directed that concurrence of the Power SSC (domain SSC) on the adoption be obtained by 10th January, 2021, post that it will be deemed approved.
- 23. **Power SSC**: Two (02) new qualifications of Power SSC were placed before the committee for NSQF alignment and approval. The Committee approved both the qualifications.
- 24. <u>Rubber SSC</u>: Seven (07) new qualifications of Rubber SSC were placed before the committee for NSQF alignment and approval. The Committee approved all seven qualifications.
- 25. <u>Telecom SSC</u>: Sixteen (16) revised qualifications of Telecom SSC were placed before the Committee for NSQF alignment and approval. The Committee approved all Sixteen (16) qualifications.
- 26. **Tourism& Hospitality SSC**: Eleven (11) new qualifications were presented before NSQC for NSQF Alignment and approval. The Committee approved ten (10) Qualifications. One qualification namely 'Sous Chef' was not approved.

Page **4** of **35**

A consolidated statement of approval status of qualifications considered in the 14th meeting of NSQC is placed at **Annexure-III**. The detailed qualification wise status is at **Annexure-IV**.

AGENDA 4: ARCHIVING OF NON ACTIVE QUALIFICATIONS

27. The Committee was informed that in the 12th Meeting of NSQC, extension of validity period was accorded to 992 qualifications till 31st March 2022. it was also decided that the Awarding Bodies had to submit a commitment for conducting a minimum nos. of trainings till 31st March 2022 for those 343 qualifications which had either zero (0) or less than 100 training numbers. Further, all other qualifications which had not been received by NCVET as on 30th September 2021 shall be archived. Accordingly, 190 qualifications were identified to be archived. The list of these qualifications is at **Annexure V**.

The Committee took note of the matter and observed that the archived qualification can be reviewed for activation/ revision as and when the concerned awarding body submits any such proposal with evidence of need for the archived qualifications with or without changes.

AGENDA 5: SIMPLIFICATION OF QUALIFICATION FILE TEMPLATE AS PART OF SIMPLIFICATION OF NSQF ALIGNMENT PROCESS.

- 28. The Committee was informed that NCVET had taken several steps to simplify the NSQF alignment and approval process for an expeditious approval of qualifications. The Qualification Template has been restructured to make it more objective, simple and user friendly for all stakeholders. NSQC was apprised that two templates have been developed in this regard:
 - a) The qualification file template relating to the unorganised sectors, such as traditional heritage, and handicraft sectors, to address the requirements of the District Skill Committees (DSCs) for their local skill clusters and as required for the School Boards offering vocational education subjects.
 - b) The Generic draft Qualification Template for all other sectors is "work in progress" and comments are invited from all members at this stage. The final version would be brought before the NSQC for approval after detailed stakeholders' consultations.

The templates are placed at Annexure VI.



The Committee took note of the matter and suggested that members can share their comments on these templates latest by 15th of January, 2022. Accordingly, the final version would be brought before the NSQC for approval and thereby, new and simplified templates will be made available for all the Awarding Bodies.

AGENDA 6: APPROVAL OF QUALIFICATIONS SUBMITTED BY A GOVERNMENT/ REPUTED ENTITY OTHER THAN RECOGNISED AWARDING BODY

- 29. The Committee was apprised that under the existing process/ procedure for qualification approval NCVET permits only its recognised Awarding Bodies to submit qualifications for NSQF alignment and approval of NSQC. However, in the recent past, NCVET has been approached by Government department/ Agency, reputed Industry as well as Private Sector Organizations (which are not recognized as Awarding Bodies) with industry/ market relevant qualifications or expressing their capabilities to develop skill qualifications which are required for the current and future needs of the industry.
- 30. The Committee decided that any such quality and industry relevant qualifications may be considered for NSQF alignment and be presented before NSQC for approval, subject to fulfilling the NCVET norms and the following additional conditions:
 - a) The qualifications should be from a Government department/ Agency, reputed Industry/ private sector organizations
 - b) The qualification should be well-designed & developed, with high quality content which are customised to the industry needs;
 - c) The qualification should be relating to the skills which are in high demand in the market, the future skills required by the Industry having bright employment prospects or entrepreneurship/ self-employment opportunities;
 - d) The qualification approved under this category would become part of the National pool of qualifications in NQR under the ownership of NCVET and shall be available to all other recognised Awarding Bodies for adoption as per Adoption Guidelines;
 - e) The initial validity of such qualifications will be for a period of one year which shall be reviewed based on its usefulness, relevance and



- outcome for considering subsequent grant of regular validation period of three years by NSQC;
- f) All such approved qualifications shall be anchored and owned by NCVET and NCVET may take appropriate steps for implementation through existing Awarding Bodies in the skill ecosystem. The detailed modalities would be worked out and notified by NCVET. NCVET shall be the trustee for such qualifications.
- g) This arrangement is approved as a pilot to be reviewed after one year.
- h) All common NOSs, like, health & safety, Digital Literacy, Team Building, etc, developed either by NCVET or by Awarding Bodies will form part of the common pool of NOSs and will be anchored and owned by NCVET for adoption by recognised Awarding Bodies across all sectors as applicable

AGENDA 7: GRANT OF EXTENSION TO QUALIFICATIONS BEING RUN UNDER DEPARTMENT OF SCHOOL EDUCATION (MoE)

It was brought to the notice of NSQC that the Department of School Education, (MoE) had a total of 62 NSQF aligned and approved qualifications which are being implemented by various States at school level under the 'Samagra Shiksha Abhiyan'. Out of these, 20 qualifications were being reflected as inactive on Skill India Portal (SIP) maintained by NSDC leading to training related issues. These 20 qualifications were approved/ extended in various NSQC meetings at least up to 31st December 2021. And, out of these 20 qualifications, 12 qualifications were found active on Skill India Portal (SIP), while the remaining 8 qualifications are being shown inactive. The details are placed at **Annexure VII**.

The Committee took note of the matter and directed that all such qualifications which are being run under any Govt scheme be activated till 31st March 2022 (academic year) including the 08 inactive Qualifications. The Committee further directed that NCVET to communicate to NSDC for activating these qualifications forthwith and concerned Awarding Bodies to ensure its immediate implementation in consultation with NSDC.

AGENDA 8: APPROVAL MECHANISM FOR MODIFICATIONS/DEVIATIONS IN ALREADY ALIGNED AND APPROVED QUALIFICATIONS FOR IMPLEMENTATION IN VARIOUS SCHEMES

31. It was brought to the notice of NSQC that sometimes the approved Qualifications are tweaked by the agencies to the requirement of a particular scheme leading to deviations in the qualification which may also lead to issues in assessments and certifications. Further, many times such qualifications are implemented for durations spilling beyond the NSQC approved validity period of the qualifications. All such modifications/ deviations/ changes made in the qualifications are generally neither intimated to NCVET nor get approved by NSQC which is against the basic spirit of NSQF and may often lead to dilution of quality and standards.

32. The Committee took note of the matter and gave following decisions in this regard:

- a) Concerned Awarding Body to submit the details of all such qualifications, including any modification to the structure and/ or validity of such qualification, within two weeks of the enlistment of such qualifications in any scheme to NCVET and any deviations in NSQC approved qualifications should be got approved from NSQC.
- b) Whenever, the revised qualifications are got approved by the Awarding Body under which the training is in progress under any schemes (the admission should have taken place before the approval date of the revised qualifications), the existing qualifications as on the date of admission (and not the revised qualification) would apply to the on-going training schemes/ training batches for training and assessments and these shall be valid for the trainees admitted under that scheme till the end of the training and assessments.
- c) All stakeholders of the skilling eco-system including Central Ministries, State Govt, UGC institutions, AICTE institutions, School Boards, NSDC etc are advised to follow the provisions of para 13 of the Government of India, NSQF Notification No 8/6/2013 dated 27th December 2013, and should also ensure that the qualifications being run under their aegis are as duly approved by the authority notified by Government of India for the purpose i.e. NSQC/ NCVET.
- d) As soon as any approved Qualifications is archived or deactivated or its validity expires, the Awarding body concerned as well as NSDC shall inform



the stakeholders and withdraw the same from SIP immediately so that no agency/ TP could offer such qualifications to anyone under any scheme or carry out admissions against such qualifications. In case any student/ trainees are admitted under any deactivated/ archived/ expired qualification or NSDC has not taken it out from SIP, the Awarding Body concerned, the Training Partner/ Training Centers (TP/TC) or NSDC, as the case may be, shall be responsible for any legal/ financial consequences thereof.

THE ADDITIONAL DECISIONS:

- 33. Member from AICTE, Dr. Neetu Bhagat, apprised the Committee that their internship policy allows student to do either internship or NSQF aligned courses pegged at level 3, 4 and 5 and recommended that in place of the apprenticeship training these short-term training courses can be taken by trainees as a module with suitable modification of adding project work and number of notional hours.
- 34. The Committee appreciated the recommendations and decided that any NSQF aligned qualification with entry requirements as class 10th pass with 2 years of experience can be offered to the engineering students (2nd year onwards). It was also suggested to the concerned SSCs that they may bring the Qualifications with amended entry requirements with suitable modification of adding project work and number of notional hours so as to cater to the training needs of the engineering students.
- 35. The Committee decided that the notional hours for the Qualifications being considered for NSQF alignment shall be in the multiple of 20/30 hours, as far as possible, for credit assignments under the Unified Credit System under development.
- 36. As a Unified Credit Framework is already being developed for implementation across schools education, higher education and vocational education and training, we need to moderate and propose the entry qualifications very diligently for assignments of levels. E.g. the Qualifications with the entry requirements as "Ability to read and write" could be considered for NSQF alignment up to 'Level 3' only.

The meeting ended with a vote of thanks to the Chair.




