MINUTES OF THE 17th MEETING OF NATIONAL SKILLS QUALIFICATIONS

COMMITTEE (NSQC) OF NCVET HELD ON 31st March 2022

1. The **17**th meeting of the National Skills Qualifications Committee (NSQC) under National Council of Vocational Education and Training (NCVET) was held on 31st March 2022, through Video-Conferencing, under the Chairmanship of Dr Nirmaljeet Singh Kalsi, Chairperson, NCVET. The list of participants is at **Annexure-I.**

2. The decisions taken by the Committee, w.r.t agenda items, in the meeting are given in the succeeding paras.

AGENDA-01: CONFIRMATION OF MINUTES OF THE 16th MEETING OF NSQC HELD ON 24TH FEBRUARY,2022

3. The Committee **confirmed** the minutes of the 16th Meeting of NSQC held on 24th February 2022.

AGENDA-02: ACTION TAKEN REPORT ON DECISIONS TAKEN IN MEETINGS OF NSQC

4. The Committee was given a detailed account of the actions taken on the Minutes of the 15th and 16th NSQC meeting wherein compliance on conditionally approved qualifications from various Submitting Bodies had been received and uploaded on National Qualification Register (NQR) Website. Action taken on the pending compliances is given below:

4.1 Action taken report on the decisions taken in 15th NSQC Meeting:

AGENDA-03: APPROVAL OF TWO (02) QUALIFICATIONS OF HEALTHCARE SECTOR-'GENERAL DUTY ASSISTANT' & 'HOME HEALTH AIDE' FOR IMPLEMENTATION IN SCHOOLS

5. The Committee was apprised that in the 6th meeting of NSQC held on 19.05.2015 under erstwhile NSDA, the Qualification 'General Duty Assistant', referred as Version-1, (NSQF Level 4) with 420 notional hours was approved. This qualification was taken from NQR and implemented by the Department of School Education for classes 9-12 in consultation with Health Care SSC and NSDC but without any intimation to NSDA/NCVET.

6. Consequent to the policy decision taken by MoHFW with respect to the skilling programs, it was decided that the term 'Aide' is appropriate for a candidate with minimum Class 10th standard qualification and the term 'Assistant' is appropriate for a candidate with minimum Class 12th standard qualification.

7. Further in the 5th meeting of NSQC under NCVET held on 29.01.2021, the notional hours of the qualification 'General Duty Assistant' was revised to 1000 hours by adding 580 hours of OJT. Thus, revised qualification was referred as 'Version- 2' and the same was approved and accordingly the Version 1 was replaced by the Version-2 as mentioned above and Version-1 was archived.

8. Consequent to the decision of NSQC regarding archiving of Version-1 of the qualification, the Department of School Education (DoSEL) raised a concern over implementing a course of 1000 notional hours at school level. DoSEL thereby requested NCVET to allow them to complete the ongoing training of students who were already enrolled under Version-1 and for permission to continue with this version for the new academic session as well. Since the qualifications pertained to the regulated sector, they were referred to MoHFW for their views.

9. MoHFW recommended that the nomenclature of qualification, Version-2 being offered in schools, be modified as under:

- a) 'General Duty Assistant'(V2) To 'General Duty Assistant-Trainee/ Inductee' and;
- b) 'Home Health Aide'(V2) –To 'Home Health Aide Trainee/Inductee'.

10. It was also recommended by MoHFW that to get the NCVET certificate of General Duty Assistant or Home Health Aide, a student would have to undertake additional training in the form of OJT of 580 hours and 640 hours respectively, after completion of school education, in order to get a certificate. MoHFW further communicated that the prescribed arrangement would only be applicable for the academic year 2022-23, for students already enrolled.

11. Based on the recommendations of MoHFW, the following course of action was proposed by NCVET and approved by NSQC:

a) The Version- 2 of the above-mentioned qualifications to be approved for schools with the revised names: General Duty Assistant - Trainee and Home Health Aide-

Trainee, both with 420 notional hours each.

- b) Should the student desire to get the NCVET certificate of General Duty Assistant or Home Health Aide, they will have to undergo the OJT of 580 hours and 640 hours respectively, as required under NSQF aligned and approved Version 2 of the said qualifications.
- c) The aforesaid proposal would be applicable only for already enrolled batches till the academic year 2022-23.
- d) The snapshot of qualification has been given under Annexure V.

12. The Committee also advised Healthcare Sector Skill Council to communicate to the NCVET an **implementation plan** for conduct of OJT and its assessment for those students who may be desirous of obtaining a certificate of General Duty Assistant or Home Health Aide; and for creating awareness among all such trainees regarding the same. Both DoSEL and Healthcare Sector Skill Council agreed to have a joint meeting to build common understanding on the future course of action in this regard.

13. Constitution of a Joint Working Group

13.1 The Committee was informed about the New Education Policy, 2020, and the ongoing formulation of policy on 'Unified Credit Framework (UCF)' wherein the vocational education would be integrated with general education with the provision for accumulation and redemption of credits in a Unified Credit Bank. With this many more NSQF aligned and approved qualifications are likely to be considered for inclusion in school education for the benefit of the students and thus, current number of 62 courses being run under 'Samagra Shiksha' by Dept of School Education may also increase manifold.

13.2 Further, as per the current practice being followed by the DoSEL, NSQF aligned and approved qualifications are taken from the NQR and adapted for implementation at school level with necessary tweaking without any intimation to NCVET. This, at times, leads to avoidable regulatory issues.

13.3 In order to streamline and smoothen this process, it was proposed before the Committee that a **Joint Working Group** be constituted with members from DoSEL, CBSE NCERT and PSS Central Institute of Vocational Education (PSSCIVE)selected stakeholders, to formulate 'Guidelines on the Mechanism for Implementation of NSQF Aligned and Approved Qualifications in Schools'.

The Committee agreed to the proposal referred in para 13.

AGENDA- 04: GRANT OF EXTENSION TO REVISED QUALIFICATIONS VALID TILL 31ST MARCH 2022

14. The Committee was apprised that in the 12th meeting of NSQC held on 20th September 2022, extension of validity was accorded to 992 qualifications of various Sector Skill Councils till 31st March 2022 and the concerned SSCs were to rationalize, revise and resubmit qualifications to NCVET for NSQF alignment and approval by NSQC.

14.1 The Committee was further informed that in the 13th meeting of NSQC, it was also decided that all such qualifications having less than 100 numbers of training would be required to submit a commitment of conducting a minimum number of trainings till 31st March pending/failing which the qualifications shall be archived. Accordingly, **70 qualifications** have been **archived by NCVET** due to non-submission of the written commitment by the concerned Awarding bodies. Further, NCVET has received 172 qualifications as on date, duly revised or rationalized.

14.2 Keeping in view the gestation period of 60 days at NCVET, for detailed scrutiny and consultation with SMEs and stakeholders, it was proposed that of the qualifications which were granted extension till 31st March 2022, those which have been submitted to NCVET till 31st March 2022, be accorded an interim extension of two (02) months i.e., till 31st May 2022 or till a decision is taken by NSQC, whichever is earlier.

The Committee approved the proposal.

However, it was further specified that the two months' extension has been granted by NSQC for the last time and no further extension will be given to any qualifications mentioned above.

Further, NSQC advised the NCVET to publish the list of all such qualifications which were granted extension till 31st March 2022 but had not submitted them for revision by the cut-off date; and deactivate such qualifications with effect from 15th April 2022.

The list of qualifications proposed for two (02) month extension has been given under **Annexure-III**

AGENDA-05: RATIFICATION OF 14 QUALIFICATIONS OF AGRICULTURE SSC

15. The Committee was informed that the Agriculture Sector Skill Council (ASCI) had submitted the recently approved 14 revised qualifications in 16th NSQC with slightly revised entry criteria to align it as per the standardized NSQF parameters to ensure wider outreach, better inclusivity and clarity for the students/ learners. The proposed additional options for the entry criteria proposed by the Agriculture Sector Skill Council are given below:

NSQF Level	Additional Entry Requirement requested for incorporation in approved QF
3	8 th Class pass and pursuing continuous regular schooling (9 th and 10 th)
4	10 th Class pass and pursuing continuous regular schooling (11 th and 12 th)

The Committee was apprised that as the above mentioned 14 qualifications were already approved and required minor addition in entry level criteria in line with the standardized NSQF parameters, the same was approved on file and now brought before NSQC for ratification.

The details of fourteen Qualifications are attached as Annexure-IV.

The Committee took note of the same and ratified the proposed changes.

AGENDA- 06: RATIFICATION OF THE PROPOSAL FOR MODIFICATIONS IN THE ENTRY CRITERIA OF QUALIFICATION "INLAND CAPTURE FISHERMAN CUM PRIMARY PROCESSOR" OF AGRICULTURE SSC

16. The Committee was apprised that the Agriculture Sector Skill Council (ASCI) has submitted a proposal to rationalize the level of already approved qualification **"Inland Capture Fisherman cum Primary Processor"** from Level 4 to Level 3 and include "ability to read and write" in place of "10th Class with 2 Years of relevant experience" in the entry requirement criteria in line with the approved standardization of qualifications norms for NSQF alignment and approval. The details are as under:

The same was approved on file and now brought before NSQC for ratification.

The Committee took note of the same and ratified the proposal.

Agenda-07: Adherence to Timelines for Obtaining the concurrence/ clearance / response/ comments From Line Ministries on Qualifications for NSQF Alignment & Approval.

17. In the 19th NSQC meeting (under erstwhile NSDA) held on 5th February 2018, it was agreed that Awarding Bodies would be required to obtain Line Ministry concurrence/ evidence of consultation before submitting the qualifications for NSQF alignment and approval of the NSQC. Accordingly, all ABs/ SSCs were requested to consult their concerned line ministries for their views/ concurrence on their qualifications. This was particularly mandatory for qualifications in the regulated sectors like healthcare and aviation.

18. The Committee was further informed that keeping in view the difficulties as highlighted in para above, in the 3rd meeting of NSQC meeting in NCVET held in September 2020, it was decided that barring the regulated sectors like healthcare and aviation, where line ministry concurrence remains an essential criteria, for all other sectors, a waiting/ response time of **four weeks** would to be given to the SSCs/ Awarding Bodies i.e. time limit of four weeks from the date on which the concurrence has been sought from the Ministries, for giving clearance/ response/ comments after which the qualifications could be placed before NSQC subject to the concerned awarding body submitting the evidence of proof related to communication made with the line ministry concerned.

19. The Committee was further informed that in case of Ministry of Health and Family Welfare (MoHFW) there has been inordinate delays in receipt of response due to which the Healthcare Sector Skill Council and other submitting bodies like the DGT have not been able to submit their important and much required qualifications related to health sector even after having got the endorsement from the reputed health institutes from public and private sectors like AIIMS, Medanta, Sir Ganga Ram Hospital, Narayana Health, Fortis etc.

20. In the light of the facts enumerated in the above paras, following was proposed for the consideration of NSQC:

- a) A written communication be sent from Ministry of Skill Development and Entrepreneurship (MSDE) to all Ministries dealing with skill related qualifications to accord PRIORITY in responding to the communication made to them either by the concerned Awarding Body or NCVET and clear the same within the stipulated four (04) weeks of having initiated the communication.
- b) However, in case of the regulated sectors like Aviation and Health, the response time can be increased to **eight (08) weeks** or else the Line Ministry may specify the time required by them to respond, by the next NSQC meeting.
- c) For facilitating the process, in case no response is received from the Ministries concerned by the next meeting of the NSQC, the eight (08) weeks deadline would apply for such regulated sectors instead of four (04) weeks for the other Ministries.
- d) The concerned Ministries dealing with the skill ecosystem may be requested to nominate a nodal officer (government officer) and share their contact details with NCVET and concerned Awarding Body for ease of connecting and communicating.

21. The Committee took note of the above-mentioned proposals and accorded approval to the Agenda Item 23 (d). NSQC further advised NCVET that before resorting to the provisions of 23(b) and 23(c) above a letter may be sent to the line ministries concerned including Ministry of Health and Family Welfare (MoHFW) seeking their comments on the matter. Also, a physical meeting with all stakeholders be held at NCVET in this regard on priority. Thereafter the agenda be taken up again in the next NSQC meeting for taking a decision.

AGENDA-08: Grant of Extension to Qualifications adopted by SCPwD due to nonsubmission of corresponding revised Qualifications by the Domain SSCs

22. The Committee was apprised that in the 7th NSQC meeting held on 25th March 2021, SCPwD was given an additional six (06) months period to submit their revised qualifications from the date the approval was accorded to such revised qualifications brought by the respective domain SSCs.

23. SCPwD has intimated that there are number of adopted Qualifications of the respective domain SSCs which have their validity date till 31st March 2022 and are yet to be revised by the domain SSCs. Further, the respective domain SSCs may/ may not even revise their qualifications or may rationalize/deactivate some of their qualifications. Under such eventuality, there is a period of uncertainty in respect of revision of such qualifications adopted by SCPwD. Hence, SCPwD may be given a window period of one year to submit their qualifications after the revision by domain SSC. This will ensure continuity in visibility of such adopted qualifications on Skill India Portal (SIP) as re-activation on the SIP of the deactivated qualification takes a long time, process and efforts.

24. Keeping in view the request of SCPwD, the Committee discussed the matter in detail and following decisions w.r.t this agenda item were taken:

- a) The adopted qualifications by SCPwD from the respective domain SSCs will be considered as new qualification and shall be reflected as such on the National Qualification Register (NQR), with a separate code.
- b) The period of validity of all such adopted qualifications shall be 'one year beyond' the validity of the original qualifications of the domain SSCs from where the qualification was adopted. For example, if the validation of the qualification of the domain SSC is upto 31.03.2022 the validity of the same adopted qualification by SCPwD shall be 31.03.2023.
- c) SCPwD will follow the standard procedure laid down by NCVET for revision/ rationalization/ deactivation of any qualifications after their initial adoption.
- d) SCPwD will also maintain a close liaison with the domain SSCs whose qualifications have been adopted by them and incorporate all such relevant changes made by domain SSCs, as applicable to the especially abled trainees, including in its model curriculum before submitting the qualification for revision.

obtaining industry validations for their qualifications to which NSQC decided to consider the matter on case-to-case basis as the acceptability by the employer industry is an important factor in the matter.

AGENDA -09: SUBMISSION OF QUALIFICATIONS FOR NSQF ALIGNMENT

26. The Committee was apprised that a total of 299 qualifications (88 new and 211 revised) were received from 1st January to 31st January 2022. Of these, 287 qualifications (83 new and 204 revised) were considered for placing in the 17th NSQC meeting. The remaining 12 (03 new and 09 revised) qualifications could not be considered for this NSQC due to non-submission of complete documents. The details of 287 files placed for consideration were as under: -

- a) New QFs 83.
- b) Revised QFs 204.

27. A total of two eighty-seven (287) Qualifications are being placed for consideration of NSQC. Summary of the Qualifications is as below:

29.2 Out of the 287 qualifications considered in 17th NSQC meeting, 281 qualifications (80 New and 201 Revised) were approved, and 05 qualifications (03 new and 02 revised) were **not approved** and one (01) qualification was withdrawn by the concerned SSC. Details of the decision taken at NSQC is as under:

- a) **NIELET :** Five (05) qualifications (02 new and 03 revised) were presented before the Committee and approved.
- **b) RSA**, **Ministry of Textiles**: Twenty (20) qualifications (10 new and10 revised), by RSA, Ministry of Textiles presented before the Committee and approved.
- c) Agriculture SSC: Eighteen (18) qualifications (01 new and 17 revised) were presented before the Committee and approved.
- d) Automotive SSC: One (01) new qualification was presented before the Committee and approved.
- e) Capital Goods SSC: Thirty-Seven (02 new and 35 revised) qualifications were presented before the Committee.
 - i. The committee **approved 02 new and 21 revised qualifications**.
 - The Remaining Fourteen (14) qualifications were accorded approval for six (06) months as the number of trainings in all these 13 qualifications was less than 100.
 - iii. The Committee also advised the Awarding Body, Capital Goods SSC, to merge two (02) qualifications i.e. Polisher - Machine & Polisher - Manual as per new NSQF norms of rationalisation and resubmit in the next NSQC accordingly.
 - iv. The Capital Goods SSC was also advised to train the requisite numbers in each of the above mentioned 13 qualifications as per the prescribed time and communicate to the NSQC for further grant of extension of validity for 3 years.
- f) **Construction SSC:** Twenty-Eight (02 new and 26 revised) qualifications were presented before the Committee.
 - i. Twenty-seven (02 new and 25 revised) qualifications were approved
 - ii. The remaining one (01) qualification 'Mason Stone' was given approval for **six (06) months** as the number of trainings was less than 100.

- iii. The Construction SSC was advised to conduct the requisite numbers trainings in this one qualification as per the prescribed time and communicate to the NSQC for further grant of extension of validity for 3 years which shall be approved at the level of the Chairperson without again referring the matter to NSQC.
- **g)** Electronics SSC: Twelve qualifications (09 new and 3 revised) were presented before the Committee and approved.
- h) Food Processing SSC: Two (02) qualifications (01 new and 01 revised) were presented before the Committee and approved.
- i) Healthcare SSC: Eight (08) qualifications (06 new and 02 revised) were presented before the Committee and approved.
- **j) Indian Iron and Steel SSC:** Twenty-Seven (27) revised qualifications were presented before the committee.
 - i. Out of these 18 qualifications were granted approval for extension of validity for three years,
 - ii. The remaining 09 qualifications was granted approval for extension of validity for **6 months** due to inadequate training numbers.
 - iii. **Indian Iron and Steel SSC** was advised to conduct the requisite numbers trainings in each of these 09 qualifications as per the prescribed time and communicate to the NSQC for further grant of extension of validity for 3 years which shall be approved at the level of the Chairperson without again referring the matter to NSQC.
- **k)** Life Sciences SSC: Four (04) revised qualifications were presented before the Committee.
 - i. One revised qualification was approved.

- ii. The remaining three (03) revised qualifications was given approval for six
 (06) months as the number of trainings was less than 100.
- iii. The Life Sciences SSC was advised to conduct the requisite numbers trainings in each of these 03 qualifications as per the prescribed time and communicate to the NSQC for further grant of extension of validity for 3 years which shall be approved at the level of the Chairperson without again referring the matter to NSQC.
- I) Logistics SSC: Five (05) revised qualifications were presented before the committee.
 - i. **These were** approved for **six (06) months** as the number of trainings was less than 100.

- ii. The Logistics SSC was advised to conduct the requisite numbers trainings in each of these 05 qualifications as per the prescribed time and communicate to the NSQC for further grant of extension of validity for 3 years which shall be approved at the level of the Chairperson without again referring the matter to NSQC.
- **m) Media & Entertainment Skills Council:** Nineteen (19) new qualifications were presented before the Committee and approved.
- **n)** Automotive SSC: One (01) new qualification was presented before the Committee and approved.
- o) NASSCOM SSC: Thirteen (13) new qualifications were presented before the committee.
 - i. The committee **approved ten qualifications**. One qualification was withdrawn by the NASSCOM SSC.
 - ii. It was represented by the CEO Media Sector Skill Council that two (02) qualifications, namely, **ARVR Developer** and **ARVR Designer** have already been presented by Media SSC earlier in the 14th NSQC and approved.
 - iii. The committee advised the NASSCOM SSC to compare the contents of already approved qualifications of media SSC in consultation with them and reconcile accordingly. However, if the content is different the matter be brought before the NSQC in next meeting/on file for further consideration.
- **p) Power SSC:** Fourteen (14) revised qualifications were presented before the Committee.
 - i. 12 revised qualifications were approved.
 - ii. The Remaining two (02) revised qualifications were given approval for six (06) months as the number of trainings was less than 100.
 - iii. The Power SSC was advised to train the requisite number as per the prescribed time and communicate to the NSQC for further grant of extension of validity for 3 years.
- **q) Paints and Coating SSC:** Eight (08) revised qualifications were presented before the Committee.
 - i. 05 revised qualifications were approved.
 - ii. Remaining three (03) revised qualifications were given approval for six (06) months as the number of trainings was less than 100.
 - iii. The Paint and Coating SSC was advised to train the requisite number as per the prescribed time and communicate to the NSQC for further grant of

extension of validity for 3 years.

- r) Rubber SSC: Twenty-Nine (10 new and 19 revised) qualifications were presented before the committee.
 - i. NSQC accorded approval to 10 new and 17 revised qualifications.
 - ii. Two qualifications were given approval for **six (06) months** as the number of trainings was less than 100.
 - iii. The Rubber SSC was advised to conduct the requisite numbers trainings in each of these 02 qualifications as per the prescribed time and communicate to the NSQC for further grant of extension of validity for 3 years which shall be approved at the level of the Chairperson without again referring the matter to NSQC.
- s) Sports SSC: Four qualifications (01 new and 03 revised) of Sports SSC were presented before the committee.
 - i. NSQC accorded approval to one (01) revised qualification namely "sports Masseur".
 - ii. The remaining three (03) qualifications (01 new and 02 revised) were **not approved** owing to the issue related to the nomenclature of the qualifications and its modalities of conduct. While the committee appreciated the intent behind bringing in such qualifications, however, it was of the view that the title of the qualifications is not clearly reflecting the purpose of the qualification.
 - iii. It was further decided that a separate meeting be held with Sports SSC in consultation with representatives from CBSE and department of school education to decide the modalities of implementing such qualifications.
 - iv. Once a consensus is reached between the SSC, NCVET and CBSE/ DoSEL, the qualifications shall be presented on file for further consideration and approved at the level of the Chairperson as the same are to be offered from the next academic session.
- t) **Textiles SSC:** Twenty-Four (24) revised qualifications were presented before the Committee and approved.
- **u) Telecom SSC:** Seven (07) qualifications (05 new and 02 revised) were presented before the Committee and approved.
- v) Skill Council for Person with Disability (ScPwD): Two (02) new qualifications were presented before the Committee and approved.
