

**MINUTES OF THE 32nd MEETING OF NATIONAL SKILLS QUALIFICATIONS
COMMITTEE (NSQC) HELD ON 29th September 2023**

The **32nd meeting** of the National Skills Qualifications Committee (NSQC) was held on **29th September 2023**, through Video conferencing, under the Chairpersonship of Dr. Nirmaljeet Singh Kalsi, Chairperson, National Council of Vocational Education and Training (NCVET). The list of participants is at **Annexure- I**.

The decisions taken by the Committee, w.r.t agenda items, in the meeting are given in the succeeding paras.

1. AGENDA ITEM 01: Confirmation of the Minutes of the 31st Meeting of NSQC held on 31st August 2023

1.1 The Committee **confirmed the Minutes** of the 31st meeting of the NSQC held on 31st August 2023 and took note of the editorial corrections in the Minutes of the previous Minutes of the Meeting and approved the same.

2. AGENDA ITEM 02: Action Taken Report on the Decisions Taken in the 31st Meeting of the NSQC

2.1 The detailed account of the **action taken** was presented before the Committee on the Minutes of the 31st NSQC meeting. The Committee took note of the action taken and **approved** the same and further emphasized the following:

2.1.1 Status of 10 NSQF Aligned and Approved Foreign Language Qualifications submitted by English & Foreign Languages University, Hyderabad (EFLU) duly recommended by UGC

The Committee was given the status update regarding 10 NSQF aligned and approved foreign language qualifications submitted by English & Foreign Languages University (EFLU). It was apprised to the Committee that information is still awaited with regard to the conduct of trainings on the 10 qualifications which were approved in the 19th meeting of NSQC dated 26th May 2022. The Committee was further apprised that NCVET has written a letter to EFLU and UGC dated 17.08.2023 requesting to expedite the progress of training and development of similar qualifications at NSQF level 2 and 3 and the compliance is still awaited.

The Committee took note of the same and emphasized on the importance of offering these courses at the Higher Education level and requested UGC to issue directions to the concerned universities to expedite the feedback including the training numbers conducted by them. Further, the Committee also decided to request EFLU to expedite submission of NSQF level 2 and 3 of afore-mentioned 10 Foreign



Language Qualifications by EFLU. The Committee suggested that these qualifications may also be offered at the school level for grades 9th and 10th for which a separate meeting with EFLU may be scheduled at mutual convenience.

2.2 PM Vishwakarma Scheme launched by MSME & MSDE.

2.2.1 In the 31st NSQC meeting, the Committee had asked NSDC to intimate the list of identified training centers (including Government ITIs, RSETI institutes, JSS Centers, MSME Tool rooms etc.) for conduct of training under PM Vishwakarma scheme. The compliance from NSDC is yet awaited.

The committee advised to follow an expeditious approach to ensure timely submission of the inputs.

2.3 Restructuring of Crafts Instructor Training Scheme CITS Qualification

2.3.1 The committee was apprised that work is under progress for 55 qualifications submitted by DGT for NSQF alignment and approval.

The committee advised DGT to follow an expeditious approach to ensure timely completion of this task.

3. AGENDA ITEM 03: Ratification of one (01) Qualification (IT-ITeS Sector) received from Ganpat University

3.1 The committee was apprised that Ganpat University had applied for seeking recognition as an Awarding Body (dual category) by NCVET. The Applicant has submitted 20 qualifications for NSQF alignment and approval. Keeping in view of the urgent need to meet the mandated requirement for signing of agreement one qualification, "**Associate Data Analyst**" was processed as per prescribed NSQF norms and accorded '**On File**' approval on 14.09.2023.

The committee took note of the same and ratified the qualification "Associate Data Analyst".

4. AGENDA ITEM 04: Operationalization of Skill India Digital (SID): Registration and on-boarding of the NCVET recognized Awarding Bodies and Assessment Agencies on SID by NCVET as part of the process of recognition

4.1 The committee was apprised that the Skill India Digital (SID) has been finally launched on 14th September 2023, which is being implemented as Digital Public Infrastructure (DPI) for skilling, education, employment and entrepreneurship ecosystem. The committee was informed that the Skill India Portal has undergone transformative changes and has been subsumed under the Skill India Digital.



4.2 The Committee had advised NSDC for creating a dashboard for NCVET on the SID portal wherein NCVET will enable registration and on-boarding of all Awarding Bodies and Assessment Agencies recognized by NCVET. All recognised entities would be required to register themselves for training, assessment and certification purposes and would be facilitated by NCVET for this purpose through the NCVET dashboard. The Committee reiterated that NSDC should immediately make the NCVET dashboard available to NCVET which should have a simplified process for registration on SID to enable registration of the recognized ABs and AAs at **no cost basis by the NCVET**.

4.3 The Committee wanted to know the status of the separate section for NCVET on the dashboard of SID portal. The representative from NSDC informed that the work is in progress and would be completed soon.

The committee took note of the same and asked NSDC that a separate section for NCVET on the dashboard of SID portal may be made operational within 4 weeks, i.e. before the next NSQC time. It was further requested that a basic dashboard with limited features and functionality may be made operational within 2.5 weeks and demonstrated to NCVET. The Committee also requested NSDC to carry out detailed training of the staff of all the recognized Awarding Bodies, Assessment Agencies and Training Partners on the Skill India Digital (SID).

The committee also advised all stakeholders (Except Defense ABs) to comply with the process of registration on SID once approved and intimate the same to NCVET accordingly.

5. AGENDA ITEM 05: Modification in the Defence Qualification - 'Foreign Language Interpreter by Army Education Corps (AEC) approved in 31st NSQC held on 31st August 2023.

5.1 The qualification **Foreign Language Interpreter** submitted by Army Education Corps was approved in the 31st NSQC for entry criteria as "BA/MA/B.Sc/ M.Sc/BCA/MCA/B.Sc IT/ BE/B Tech" and at NSQF level 4.5. The committee was apprised that the AB has requested that to ensure that any soldier from all Arms and Services meeting the entry level criteria have an equal opportunity to undergo training on this qualification as per NCrf and existing practice the entry level criteria and NSQF level for this Qualification may be revised. The details of the proposed revised entry requirements and NSQF level are tabulated below:

The committee took note of the request and approved the modifications for qualification “Foreign Language Interpreter”.

6. AGENDA ITEM 06: Status Update of existing NSQF aligned and approved Qualifications rationalized in the multiples of 30 hours and inclusion of ES module

6.1 The Committee was presented a detailed account of the status of NSQF aligned and approved qualifications rationalized with the inclusion of ES and making NOSs multiples of 30 hours, as applicable, in order to align with the National Credit Framework so that every learning hour is creditised in consonance with the provisions of NCrF. The Committee was informed that out of 2775 qualifications due for rationalization, a total of **1780** qualifications have already been rationalized. The balance **995** qualifications are yet to be rationalized. A detailed table giving the same has been attached as **Annexure II**.

The Committee took note of the same and directed all the recognized ABs to complete the rationalization of their remaining NSQF aligned and approved qualifications before the 33rd Meeting of NSQC scheduled in the month of October 2023 to ensure their seamless integration and alignment with NCrF and NSQF failing which the process of archival of the unrationalized qualifications will be initiated.

The Committee further advised the Awarding Bodies that in the process of rationalizing qualifications, if there are any changes other than the conversion of existing NOSs in multiples of 30 hours and addition of appropriate NOSs of Employability Skills (ES), the qualifications may be submitted to NCVET as a revised qualification in the standardized format.

7. AGENDA ITEM 07: NSQF alignment and approval of PM Vishwakarma qualifications (Upskilling NOS) for PM Vishwakarma scheme launched on 17th September 2023

7.1 The Committee was given a brief account of the PM Vishwakarma Scheme launched by the Hon’ble PM on 17th September 2023. The Committee was informed that in the 31st NSQC meeting, the Committee had accorded ‘in-principle’ approval to the 25 qualifications (Upskilling NOS) in 18 trades and the methodology deployed for the NSQF alignment of the PM Vishwakarma qualifications. Also, the Committee had advised that a

separate section be created on NQR for "PM Vishwakarma Scheme Qualifications".

7.2 The Committee was apprised that a separate section has been created for "PM Vishwakarma Scheme Qualifications" on NQR and the details of all qualifications, including the Model Curriculum, have been uploaded on the NQR.

7.3 Further, the Committee was informed that consequent upon the launch of the scheme, the Awarding Bodies, Handicraft sector skill Council (HSSC) and Beauty and Wellness Sector Skill Council proposed amendments as under:

7.3.1 Handicraft Sector Skill Council: The qualification "Traditional Toy maker" has four different toy making types/ components, namely, glass toys, leather toys, wooden toys and soft toys. The modern tool kits being provided for the four categories of toy making are different, hence HSSC has proposed to consider each field as a separate qualification. The qualification "Traditional Toy maker" shall be offered as:


- a) Traditional Glass Toy maker.
- b) Traditional Leather Toy maker.
- c) Traditional Wooden Toy maker.
- d) Traditional Soft Toy maker.

7.3.2 Beauty and Wellness Sector Skill Council. The qualification 'barber (नाई)' is often related to the qualifications being practiced by the male community, whereas the qualification 'Hairdresser' would be a gender-neutral nomenclature, professed by either men or women. Hence, the request has been received to consider two different qualifications with the names, barber (नाई) and Hairdresser. The qualification "Barber" shall be offered as:

- a) Barber.
- b) Hairdresser.

The Committee took note of the same and accorded approval to the PM Vishwakarma Qualifications. The Committee drew reference of the 31st Meeting of NSQC and directed that the concerned ABs to prepare the Basic modules of 40 hrs each. They were also asked to develop an additional 10 hrs of e-content for each qualification to be delivered as digital learning material (video clips in Indian languages) on learning the new toolkits which will be offered as pre-course. To save on the cost, ABs may also use already available videos on YouTube or other platforms. However, the ABs need to ensure that due written permission is taken from the person/ organization whose videos are to be embedded in the preparation of the e-content so as to avoid any infringement of copyrights.

The Committee also lauded and placed on record the efforts of all concerned stakeholders including Awarding Bodies (SSCs) i.e. NASSCOM, MEPSC, BFSI, ASCI, as also NSDC, Govt Institutions, Entrepreneurship Development Institute of India (EDI), Academic Institutions such as IIM-Indore, NIFT and NID and Banks



namely SBI, HDFC, ICICI banks, who contributed in developing various modules on financial literacy, digital literacy, marketing & branding literacy & self-employment towards making PM Vishwakarma scheme a great success.

8. AGENDA ITEM 08: Status Update on development of Modules/ Sub-Modules of Employability Skills, Life Skills and Soft Skills

8.1 The Committee was given a brief account of the flexible models of Employability Skills (ES) also encompassing Soft Skills (SS) and Life Skills (LS) being developed by NCVET as a dynamic framework. Such a framework will allow the Awarding Bodies, including HEIs and School Boards, the flexibility to develop NOSs by selecting/ assembling the appropriate modules/sub-modules as per the requirement of the job role/ qualification/ need of the industry.

8.2 The Committee was further apprised that a sub-committee comprising of various organisations like NCVET, MSDE, UNICEF, AICTE, SSCs, and Wadhvani Foundation has been constituted and working relentlessly to bring this project to implementation.

8.3 Outlining the progress made so far, the Committee was informed that the structure of nine (09) main modules with further forty- seven (47) sub-modules, in four variants of NCrf/ NSQF Levels, have been finalised. The development of the modules and sub-modules is being done in various phases. The details of the ES modules and sub-modules are attached as **Annexure III**.

8.4 The work accomplished in the first phase was apprised to the Committee wherein modules on curricula consisting of Learning Outcomes, Performance Criteria, Assessment Criteria, Trainer's/assessor' eligibility etc., for the four variants of NCrf/NSQF Levels have been developed in collaboration with the organizations such as CII, Media SSC, Management SSC, NASSCOM, Wadhvani Foundation and NIESBUD. The vetting of the same shall be completed by 15th October 2023.

8.5 The Committee was further apprised that the second phase of content development on ES modules and sub-modules encompassing student's guide; basic resources, basic e-content/ digital assets based on the model curriculum; strategy and guidelines for training and assessment; training manual for trainers, basic assignments, tutorials; ToT qualification assessment manual, practical assessments methodology; ToA qualification for the three variants will be undertaken by October 2023 and for Advance and Higher Order Variants by November 2023.

8.6 Regarding the utilization of newly developed **ES modules and sub-modules on Employability Skills, Life Skills, and Soft Skills**, it was decided that for Long Term Training courses run by DGT, DGT may continue to use its existing NSQF aligned and approved Employability Skill Modules (120 Hrs in 1st year/ 60 Hrs in the 2nd year) being



revised by them. However, once the **ES modules and sub-modules** developed by NCVET are implemented, DGT may also option to use these for its Short Terms Trainings (240 Hrs) as per the guidelines of NCVET.

The Committee took note of the progress made so far and lauded the collaborative efforts made by the stakeholders concerned in the development of the above-mentioned modules. The committee further took the following decisions:

- a) Given the pivotal importance of offering these ES modules and sub-modules in HEIs, the Committee requested inputs and suggestions on 9 modules and further 47 sub-modules finalised from UGC and AICTE for incorporation in the ES modules and sub-modules.***
- b) Regarding the cost structure to be followed for these ES modules and sub-modules, the Committee advised that these may be partially made available free of cost, especially at the lower levels, and partially could be made available on an affordable paid model, especially for higher order skills. To ensure adequate funding for the exercise, the Committee further advised that MSDE may be requested for funds for this task under project SANKALP. In addition, UGC and AICTE may also be requested for mobilization of funds for the modules being developed for Higher order skills.***
- c) The Committee emphasized on the need to offer these ES modules and sub-modules in the upcoming semester starting from January 2024 and hence advised the committee constituted for the purpose to develop the content under phase 2 and make all efforts to complete by November/December 2023 in all respects.***

9. AGENDA ITEM 09: Archival of non-active and expired qualifications of Skill Council for Persons with Disabilities (SCPwD)

9.1 The committee was apprised that SCPwD has communicated to the NCVET that 30 NSQF aligned and approved qualifications of SCPwD may be archived as these are old and there is no training conducted on these qualifications. The details of the 30 qualifications are attached as **Annexure IV**.

The committee approved the archiving of 30 qualifications of SCPwD and directed that no stakeholder should conduct any further training and certifications on the above mentioned 30 qualifications as given in Annexure IV. The Committee desired the other awarding bodies to conduct and complete similar exercises at the earliest.



The Committee further reminded all the Awarding Bodies that no qualifications should be selected by any stakeholder out of the Archived Section of the NQR portal/ listed as deactivated on the SIP/ SID for training. The Awarding Bodies/ any other stakeholder will be solely responsible for implementing any deactivated/ archived qualifications.

10.AGENDA ITEM 10: Adoption of NSQF aligned and NSQC approved common Defense Qualifications by various Directorates of Indian Army:

10.1 The Committee was apprised that Headquarters, **Army Training Command** (ARTRAC) vide letter dated 13th Sep 2023, had shared a list of 102 Common Qualifications (**attached as Annexure V**) which were proposed for adoption by various Directorates of Indian Army. The summary of the qualifications being adopted by various defense ABs is given below:

The committee took note of the same and ratified the adoption of qualifications being adopted by various Defence ABs.

The Committee also appreciated the efforts of Defence ABs of economizing the effort and time by adopting already developed NSQF aligned and approved qualifications from the already approved other qualifications of the defense ABs developed by them.

The Committee advised that a similar exercise needs to be carried out for the civil qualifications by the other Awarding Bodies with a view to reduce the duplication of efforts, qualifications and NOSs and enhance quality, effective execution & implementation. This exercise should be done at the NOS level as well.

11. Agenda Item 11: Submission of Qualifications, NOS and MC for NSQF Alignment & Approval by Awarding Bodies

11.1 The Committee was apprised that a total of 165 (138 New and 27 Revised) qualifications, 04 NOS and 09 Micro Credentials (MCs) were received at NCVET as on 22nd September 2023. Out of which, a total of 106 (102 New and 4 Revised) qualifications, 04 NOS and 08 MCs have been considered for placing in this NSQC.

11.2 The decision of the committee on all the considered qualifications, NOSs and MCs is given in succeeding paras. The detailed status of approval and decision of the committee is at **Annexure VI**.

11.3 NSQF alignment and approval of qualifications submitted by Awarding Bodies (Central Ministries/State Bodies/SSCs/Other Govt & Pvt Bodies)

11.3.1 National Institute of Electronics & Information Technology: Two (02) revised qualifications were presented before the Committee and were **approved**.

11.3.2 Shri Vishwakarma Skill University (SVSU): One (01) new qualification was presented before the Committee and was **approved**.

11.3.3 Chhattisgarh Swami Vivekanand Technical University: One (01) new qualification was presented before the Committee and was **approved**.

11.3.4 Management & Entrepreneurship and Professional Skills Council (MEPSC): Two (02) new qualifications were presented before the Committee and were **approved**.



11.3.5 Life Sciences Sector Skill Development Council: Two (02) new qualifications were presented before the Committee and were **approved**.

11.3.6 Agriculture Skill Council of India (ASCI): Nineteen (19) new qualifications were presented before the Committee and were **approved** with following changes in nomenclature.

11.3.8 Hydrocarbon Sector Skill Council: One (01) revised qualification was presented before the Committee and was **approved**.

11.3.9 Healthcare Sector Skill Council: Three (03) new qualifications were presented before the Committee and were **approved**.

11.3.10 Domestic Sector Skill Council: Three (03) new qualifications were presented before the Committee were **approved**.

11.3.11 Skill Council for Mining Sector (SCMS): One (01) new and one (01) revised qualification presented before the Committee and were **approved** with changes in nomenclature for the following qualification which was agreed upon by the AB.

11.4 NSQF alignment and approval of NOSs and Micro Credentials submitted by Awarding Bodies (Central Ministries/ State Bodies/ SSCs/ Other Govt & Pvt Bodies)

11.4.1 Automotive Skill Development Council (ASDC): Four (04) new NOSs presented before the Committee and were **approved**.

11.4.2 Life Sciences Sector Skill Development Council: Eight (08) new Micro credentials were presented before the Committee and were **approved**.

11.4.3 Management & Entrepreneurship and Professional Skills Council (MEPSC): One (01) new micro credential was presented before the Committee and was **approved subject to changes in the entry requirements** which was agreed upon by the AB.

11.5 NSQF alignment and approval of Qualifications submitted by Defense Forces

11.5.1 Directorate General of Armoured Corps: One (01) new qualification was presented before the Committee and was **approved**.

11.5.2 Directorate General of Mechanized Infantry: Two (02) new qualifications were presented before the Committee and were **approved**.

11.5.3 Directorate General of Artillery: One (01) new qualification presented before the Committee were **approved**.

11.5.4 Army Education Corps: Two (02) new qualifications were presented before the Committee and were **approved**.

11.5.5 Directorate General of Army Air Defence: Four (04) new qualifications were presented before the Committee and were **approved** subject to the change in nomenclature of one (01) qualification namely "Camp Helper Advanced" which was agreed upon by the AB.

11.5.6 Directorate General Army Service Corps: Four (04) new qualifications were presented before the Committee and were **approved**.

11.5.7 Directorate General Remount Veterinary Services: Three (03) new qualifications were presented before the Committee and were **approved**.

11.5.8 Corps of Signals: Seven (07) new qualifications presented before the Committee were **approved**.

11.5.9 Corps of Electronics and Mechanical Engineering: Seventeen (17) new qualifications were presented before the Committee and were **approved**.

11.5.10 Indian Airforce: Eleven (11) new qualifications were presented before the Committee and were **approved** subject to change in nomenclature of the qualifications.

11.5.11 Directorate General of Military Intelligence: One (01) new qualification was presented before the Committee and was **approved**.

11.5.12 Army Ordnance Services: Two (02) new qualifications were presented before the Committee and were **approved** subject to change in nomenclature of the qualifications which was agreed upon by the AB.



12. AGENDA ITEM 12: Additional Agenda/ Any Other Matter with the Permission of the Chair

12.1 NSQF alignment and approval of qualifications submitted by Defense Forces:

The Chairperson, NSQC informed that initial approval of the Defense qualifications has been done in an expeditious manner by NCVET to align the Defense qualifications as per NSQF. Because of the haste the defense qualifications have often needed frequent changes/ modifications which were to be taken-up and approved in the subsequent NSC meetings. To avoid such mistakes NCVET follows a standardized process which includes a thorough scrutiny and a comprehensive stakeholders' review of the qualifications for which a processing period of 60 days has been prescribed from the date of submission of the qualification.

The Committee advised that to obviate the frequent need for subsequent modifications in the qualifications, from now onwards all the Defense qualifications shall also undergo a stakeholders' review in which Defense qualifications will be aligned as per the industrial requirements and will, as far as possible, follow a period of 30 days.

12.2 Rationalization of PMKVY 4.0 Qualifications in the multiples of 30 hours and inclusion of ES module: PMKVY 4.0 qualifications were approved by NCVET in the 24th NSQC which took place in the month of November 2022. As of now, some qualifications may require upgradations or changes in the core content and the inputs of MSDE may also be sought in this regard. Further, as NCrF has now been notified, the rationalization of qualifications in line with NCrF has become mandatory.

The Committee directed that 611 qualifications which were approved for PMKVY 4.0 may be considered for any comprehensive revision and/ or rationalization exercise, as necessary, and should be completed before the next NSQC meeting.

12.3 Submission of ToT and ToA Calendars by respective ABs and AAs: In the 31st NSQC meeting, all the NCVET recognized Awarding Bodies and Assessment Agencies were directed to upload their Training of Trainers (ToT) & Training of Assessors (ToA) calendars on the SIP portal and on their respective websites.

The Committee reiterated that all the NCVET recognized ABs and AAs shall submit their Training of Trainers' (ToT) and Training of Assessors' (ToA) calendars before the 33rd Meeting of NSQC scheduled in the month of October 2023.



The Committee had apprised that so far only the Sector Skill Councils as Awarding Bodies have submitted the list of training centers, Assessment Agencies, trainings, assessments etc. as a part of routine monitoring by NCVET. **The Committee directed the Awarding Bodies other than SSCs shall also share the monitoring data with NCVET as also indicated in the recognition agreement.**

12.4 Submission of information regarding training conducted on Future Qualifications by the Awarding Bodies: NCVET has so far accorded approval to 350 plus Future Qualifications available on the national qualification register. However, the number of trainings conducted on these qualifications were not satisfactory. Therefore, the Awarding Bodies were advised to conduct more training in future qualifications.

The Committee directed all the Awarding Bodies to prioritize the conduct of training on Future Qualifications and intimate the status of the same to NCVET.

12.5 Content Development for AI based courses to be offered on SID: The Skill India Digital is specially designed and developed to skill, re-skill and up-skill the individuals through the online training platform, which includes features like API-based trusted skill credentials, payment and discovery layers for jobs and entrepreneurial opportunities. It has been envisaged to offer AI based skill courses on SID for various relevant sectors. Accordingly, the Guidelines prepared by NCVET on “National Program for Artificial Intelligence” have been shared with all the concerned SSCs.

The Committee advised all the concerned SSCs to prepare courses and content for the AI based courses for which a separate meeting with the SSCs has been desired by the Committee.

The Meeting ended with a Vote of Thanks to the Chair.
