The 43rd meeting of the National Skills Qualifications Committee (NSQC) was held on 8th May 2025 in hybrid mode, under the Chairpersonship of Shri Atul Kumar Tiwari, Chairperson, National Council for Vocational Education and Training (NCVET). The list of participants is at [Annexure I](#). The decisions taken by the Committee, w.r.t agenda items, in the meeting are given in the succeeding paras.

AGENDA ITEM 01: Confirmation of the Minutes of the Meeting of the 42nd National Skills Qualification Committee (NSQC) held on 18th February 2025

1.1. The Committee was apprised that the minutes of the 42nd meeting of NSQC held on 18th February 2024 were circulated and following correction were suggested:

1.1.1. Correction in the NSQF level of one qualification of HARTRON.

- a. The NSQF Level of one revised qualification "*Advanced Course in Computer Application*" was erroneously mentioned as NSQF Level 4 instead of NSQF Level 5. The corrected details of the qualifications is as follows:

AGENDA ITEM 02: Action Taken Report (ATR) on the Decisions Taken in the 42nd Meeting of the NSQC

- 2.1 A detailed account of the 'Action-Taken' with respect to the minutes of the 42nd meeting of NSQC was presented before the Committee. The brief of the action-taken/ status of compliance is attached at [Annexure II](#). The Committee acknowledged and approved the same with following directions.

2.1.1. Conditional Approval of One (01) qualification "Machine Operator' (Non-Leather Footwear Manufacturing)" of Rubber, Chemical & Petrochemical Skill Development Council (RCPSDC)

One Qualification 'namely 'Machine Operator' (Non-Leather Footwear Manufacturing)" was granted conditional approval subject to additional inputs from Leather Sector Skill Council. However, no inputs have been received from the Leather SSC.

The Committee took note of the matter and directed that in absence of inputs from the Leather SSC, the qualification is approved.



2.3.2. SSC National Association of Software and Service Companies (NASSCOM)

AGENDA ITEM 05: Ratification of 'On-File' Approval for Revision of Qualifications/NOS/MC granted Interim Extension Till 30th April 2025

5.1. The committee was apprised that the 42nd NSQC meeting accorded approval to the 455 Qualifications till 30th April 2025 which were originally due for expiry from November 2024 to April 2025. The committee also directed that ABs shall ensure that the revision of all these qualifications is done well in time before the expiry of validity i.e before 30th April 2025.



- 5.2. The committee was apprised that the exact number of qualifications is 453 instead of 455, since two (02) qualifications namely 'Manager- Waste Management' and 'Solar Photovoltaic Entrepreneur' were erroneously repeated.
- 5.3. Further, the committee was briefed that so far, of the 453 qualifications with validity till 30th April 2025, a total of 139 qualifications have been revised and granted approval in the 42nd meeting of NSQC held on 18th February 2025. Of the balance qualifications, a total of 216 Qualifications have been granted 'on-file' approval. The snapshot of 216 qualifications approved on file is as below and the detailed list of these qualifications is at **Annexure III**.

The committee was informed, that a request has been received from Agriculture SSC regarding the correction in the two qualifications approved in the 42nd NSQC meeting held on 18th February 2025 namely '**Floriculturist**' and '**Agriculture Extension Service Provider**' which was errors while submitting the agenda.

6.1.2. While making submission of the qualifications, the AB had mentioned incorrect calculation of total notional hours for '**Floriculturist**' Qualification while for the qualification '**Agriculture Extension Service Provider**' the optional elective was not mentioned. 6.3. Request for Change in Nomenclature of one (01) qualification of Management & Entrepreneurship and Professional Skills Council (MEPSC)

- 6.3.3. The Committee was apprised that request has been received from Management & Entrepreneurship and Professional Skills Council (MEPSC) for change in the nomenclature of one (01) qualification - Environmental Sustainability Governance Specialist, approved in 42nd NSQC to '**Environmental Social Governance Specialist**', to align with the industry standards.

- 6.3.4. The committee took of note the same and approved the corrections in the qualification.

AGENDA ITEM 07: Re-Activation of 99 NSQF-Aligned and Approved Qualifications that were archived in 42nd NSQC owing to non-availability of content

- 7.1. The committee was apprised that in the 34th meeting of NSQC held on 30th November 2023 the committee directed all awarding bodies to ensure availability of the content for the qualifications within three months of the NSQC approval failing which the qualifications shall be archived.
- 7.2. In line with the above mandate, all ABs were directed to submit an undertaking confirming that all NSQC approved qualifications have content (Participant Handbook and Facilitator Guide) available. Accordingly, in the 42nd NSQC meeting, a total of 753 qualifications were approved for archival due to non-availability of required content (Participant Handbook and Facilitator Guide) beyond the 90-day timeframe post NSQC approval based on undertakings submitted by 74 Awarding Bodies. The Committee had also directed remaining 16 Awarding Bodies, which had not submitted the undertaking till 42nd NSQC be informed to comply with the instructions of NSQC pending which strict action including temporary suspension/de-recognition may be taken along archival of all existing qualifications.



7.3. In compliance with the directions of NSQC, a communication was shared with the ABs to comply with the NSQC direction vide email dated 6th May 2025. Accordingly, the undertaking has been received from the following ABs:

- a. Lamrin Tech Skills University
- b. HCL Technologies
- c. Ganpat University
- d. Gujarat Council of Vocational Training
- e. Bajaj Finserv
- f. Microsoft

7.4. The committee gave instructions that a one final reminder may be sent to all the following ABs to ensure submission of undertaking regarding availability of content by 30th May 2025, pending which strict action may be taken against the ABs as per the decisions of previous NSQC.

- 7.6. The committee took note the same and approved the re-activation of 99 qualifications of four awarding Bodies and also gave strict instructions that availability of content is mandatory and a regular audit of the same may be undertaken by NCVET. Additionally, the committee directed that the thirteen (13) ABs which have not submitted the undertaking may do so on priority, pending which, all their existing qualifications shall be archived as well as strict action including suspension/derecognition shall be taken.

AGENDA ITEM 8: Removal of the Age Criteria mentioned in the Qualifications and Age to be mentioned only in case of Legal Requirement and for Hazardous Jobs

- 8.1. The Committee was apprised that the NSQF alignment and approval of qualification is a comprehensive process covers various aspects like minimum notional hours; minimum entry requirements; evidence of need; NSQF level in alignment with the level descriptors; progression pathways as well as age requirement in case of hazardous job/ legal requirements.
- 8.2. It has been observed that although the standard qualification file template refers to age as training age only in cases where there is a legal requirement, the ABs while submitting the qualification prescribe the age for all types of qualifications, even though it's not mandatory. Accordingly, the age being listed as part of qualification becomes a necessary criterion for training in the said qualification/s and at times becomes an impediment in implementation of qualification in various schemes.
- 8.3. The committee was informed that to address the above concerns, it is proposed that for all other NSQF aligned and approved qualifications, the age mentioned as part of the qualification file shall be deemed to have been removed apart from the following cases:
- i. Qualifications/Job-roles related to hazardous occupations.
 - ii. Qualifications mandating legal requirements.
 - iii. Qualification with specific/ special requirements.
- 8.4. Further, the committee sought clarity on how this exercise would be undertaken, to which the committee was informed that as first step, the ABs would be asked to inform and share the list of qualifications where age is to be retained in accordance with para 8.3 above. In case no communication is received from the AB, within prescribed time, it shall be presumed that AB has no objection in withdrawal of age criteria from the qualifications.
- 8.5. The committee approved the same and directed that an office order may be issued by NCVET to seek the inputs of age requirement in qualifications as per the categories mentioned above.



AGENDA ITEM 9: Archival/Deactivation of Non-Active and Expired qualification from NQR Portal

- 9.1. The committee was informed that the National Qualification Register (NQR) portal is a centralized repository for all qualifications which are National Skills Qualification Framework (NSQF) aligned and approved by NSQC. These qualifications are approved with a validity period of 3 years, unless otherwise specified by the NSQC. Since the operationalization of NCVET, 8505 qualifications have been NSQF aligned.
- 9.2. NCVET follows the prescribed process of periodical archival of qualifications which fall under the below mentioned criteria:
- a) The validity of the qualification has expired and the concerned awarding bodies has not taken up the same for revision, hence all such qualification are deemed to be not required in the skill ecosystem.
 - b) Any entity which had got the qualifications NSQF aligned either during the time of NSDA or till 2021 with NCVET and is presently not a recognized awarding body (AB) of NCVET.
 - c) All such Qualifications where there is no/low training conducted and/or are inactive for more than a year.
 - d) Qualifications which have not been rationalised as per the National Credit Framework (NCrF) and revised National Skills Qualification Framework (NSQF).
 - e) NCVET recognised Awarding Body has requested for deactivation/archiving of their qualifications.
 - f) Qualifications which have no content (i.e trainers handbook and participant handbook) available even after 90 days of NSQC approval.
- 9.3. The archival of qualification is a continuous process and as on 4th May 2025 while NQR portal has 2685 active qualifications, a total of 5,820 qualifications have been archived based on approval in various NSQCs.
- 9.4. The committee was updated that in line with the above, pursuant to the mandate and in accordance with the directions of NSQC to conduct regular audit of the NSQF aligned and approved qualifications to ensure that only the industry-relevant and active qualifications are seen on the public portal, NCVET had now identified 607 Qualifications (versions) that needs to be archived.
- 9.5. **The committee appreciated the efforts being made to ensure only relevant and demand driven qualification exist in the ecosystem and also advised that the qualifications may be archived after diligent and detailed analysis. For all qualifications being archived, it is important to highlight the reasons of archival and availability of the latest version of these qualifications, if applicable. An objective analysis may be undertaken to capture the**



performance of Awarding Bodies in bringing currency and relevance to the skill ecosystem.

Agenda Item No. 10: Introducing a System of Re-Assessment and Fixing the Minimum Pass Percentage for Skill Based Courses in Vocational Education, Training and Skilling (VETS)

- 10.1. The committee was apprised that pursuant to the decision taken during the 35th NSQC meeting held on 31st January 2024, a *Sub-Committee on Re-assessment and Fixing the Minimum Pass Percentage for Skill Based Courses in VETS* was constituted. The Sub-Committee undertook a study of qualifications offered by all Awarding Bodies (ABs) using a data-driven methodology. Accordingly, the Consultations were held with key stakeholders, including the Directorate General of Training (DGT), the National Academy of RUDSETI, Higher Education Boards, Universities, School Education Boards, Assessment Agencies (AAs), and representatives from Industry.
- 10.2. During the consultation, it was noted that the skilling ecosystem in India is highly diverse, encompassing a wide range of learner profiles, implementation modes, and institutional frameworks. Furthermore, with the integration of the National Education Policy (NEP) and associated frameworks such as National Curriculum Framework (NCF), NHEQF (National Higher Education Qualification Framework), and the revised NSQF (National Skills Qualification Framework), a flexible and learner-centric approach is being emphasized, rendering a uniform or rigid benchmark unsuitable.
- 10.3. The committee was informed that the final recommendation of the *Sub-Committee on Re-assessment and Fixing the Minimum Pass Percentage for Skill Based Courses in VETS* are as follows-

a. Minimum Pass Percentage

- i. It is not advisable to establish a uniform minimum pass percentage. However, the Awarding Body shall ensure that the prescribed minimum pass percentage is not less than 33%—in parlance with the widely accepted standards, especially in academics, in the country.
- ii. Awarding Body shall define the prescribed minimum pass percentage for all NSQF-aligned qualifications in the Qualification-file (Q-file).
- iii. The apex body i.e. National Skills Qualification Committee (NSQC) entrusted with the approval of qualifications shall undertake a thorough scrutiny of each qualification and grant approval.



b. Re-assessment strategy

- i. A learner shall be eligible for re-assessment. It shall be available for entire learning unit i.e. Qualification/ Standalone NOS/ Standalone Micro Credential (MC)/ Standalone Nano Credential (NC) for which the assessment has been conducted.
- ii. The number of times re-assessment may be availed shall be prescribed by the AB. However, the AB shall ensure that the timeline does not exceed three years from the publication of the initial result of learning unit i.e. Qualification/ Standalone NOS/ Standalone Micro Credential (MC)/ Standalone Nano Credential (NC).
- iii. Details of re-assessment should not be reflected in any of the learner's document (like mark sheet, certificate etc.) for all qualifications.

10.4. The committee took note and approved the same. The Committee also directed that an office order in this regard be issued at the earliest.

AGENDA ITEM 11: Submission of Qualifications for NSQF Alignment & Approval

- 11.1. The committee was apprised that a total of **353** Qualification/NOSs/MCs/NCs have been **received** at NCVET till February 2025. Of these, **197** Qualification/NOSs/MC/NC are meeting the criteria for being placed for consideration in NSQC while the balance **156** Qualifications/NOS/MC are not being placed owing to compliance issues. The details of **197** qualifications being considered is at **Annexure V**.

11.4.1 Directorate General of Training (DGT) - The following four (04) qualifications of DGT were presented before the committee and granted approval:

- a. Three (03) new qualifications pertaining to the Automotive sector were approved with change in notional hours from 3600 hours to 3200 hours.
- b. One (01) revised qualification pertaining to the logistics sector.

11.4.2 Delhi Metro Rail Corporation Academy (DMRCA) - Three (03) qualifications in the logistics sector of DMRC Academy were presented before the committee and granted approval subject to change in entry criteria in one qualification namely Supervisor- operations (Metro rail) detailed below.

11.4.5 Indian Institute of Technology (IIT), Mandi - Fourteen (14) new NOSs in the IT-ITeS sector presented before the Committee were approved.

11.4.6 MSME Technology - The following eight (08) new qualifications of MSME technology centre were presented before the committee and granted approval:

- a. One (01) new qualification in the Glass & ceramic sector
- b. One (01) new qualification in the Power sector
- c. Four (04) new qualification in the Leather sector
- d. Two (02) new qualification in the Capital goods sector.

11.4.7 National Film Development Corporation (NFDC) - Two (02) new Micro-Credentials were presented before the committee and were not approved.



11.4.8 National Institute of Electronics and Information Technology, Delhi (NIELIT)

- The following eight (08) Qualifications/NOS/MC were presented before the committee.

- a. One (01) revised Qualification, two (02) revised NOS, two (02) new NOS of IT-ITeS sector were granted approval.
- b. One (01) new NOS of the Electronics sector were granted approval.
- c. Owing to less training numbers, one revised NOS of IT-ITeS sector namely "Fundamentals of Information security" and one revised NOS of electronics sector namely "Fundamentals of Internet of Things" were granted conditional approval subject to submission of evidence-based projections within 15 days of NSQC. Post submission, the approval of these NOSs shall be valid for a period of 06 months from the date of NSQC.

11.4.9 West Bengal State Council of Technical & Vocational Education & Skill Development (WBSCTVESD) - Three (03) new qualifications in the Handicraft & Carpet sector presented before the Committee were approved

11.4.10 Agriculture Skill Council of India (ASCI) - Two qualifications (one new and one revised) and one (01) new Micro-Credential in Agriculture sector presented before the Committee were approved.

11.4.11 Aerospace and Aviation Sector Skill Council (AASSC) - Nine qualifications (three new and six revised) were presented before the Committee were approved subject to change in nomenclature for two (02) new qualifications as below.

The balance two new (02) Qualifications namely 'Automotive CAD Technician' and 'Automotive Material Handling Operator' were conditionally approved subject to submission of additional industry validations.



11.4.13 Capital Goods and Strategic Skill Council (CGSSC) - Thirteen (13) new qualifications pertaining to the Capital goods sector were presented before the committee.

- a. Ten (10) new qualifications were approved.
- b. Three (03) new qualifications namely “Metal Fabrication Engineer”, “Additive Process Engineer” and Advance Mechatronics simulation Engineer” were conditionally approved subject to change in the nomenclature of qualifications corresponding to level 5.5 and removal of the word “Engineer”.

11.4.14 Construction Skill Development Council of India (CSDCI) - One (01) new qualification in the Construction sector presented before the Committee was approved.

11.4.15 Electronics Sector Skill Council of India (ESSCI) - Two (02) revised qualifications in the electronics sector were presented before the committee and were approved.

11.4.16 Food Industry Capacity and Skill Initiative (FICSI) - A total of eight (08) new Qualifications/NOS/MC (Two qualifications, three NOSs and three Micro Credentials) presented before the committee were granted approval subject to the following changes.

- a. Lowering of NSQF level of the qualification “Sales Associate- Food Industry” from 4.5 to **NSQF level 4.0**.
- b. Change in entry level criteria of the qualification “Sales Associate- Food Industry” as follows:

AGENDA ITEM 12: Additional Agenda with Permission of Chair

12.1. Considering 7 qualifications of Apparel SSC as revised qualifications

12.1.1. The committee was apprised that Apparel Made-ups and Home Furnishing Sector Skill Council (AMHSSC) has submitted a request to consider that the following seven qualifications as revised qualifications instead of rationalized qualifications:

- i. Hand Embroiderer Addawala
- ii. Sewing Machine Operator
- iii. Sewing Machine Operator Knits
- iv. Finisher and Packer
- v. Self Employed Tailor
- vi. Washing Machine Operator
- vii. Specialized Sewing Machine Operator

12.1.2. The version 4 of these qualifications was granted approval in 33rd meeting of NSQC held on 1st Nov 2023 as rationalized qualifications. The qualifications were extensively reviewed, and modifications were made with respect to entry requirements and NSQF levels.

12.1.3. The committee took note of the matter and accorded approval to these 07 qualifications as revised qualifications with a validity till 1st Nov 2026. The committee also directed that all previous versions, if existing, in these qualifications be archived with immediate effect and no new batches be formed on the same.

12.2. Other Decisions taken by the NSQC

12.2.1. The committee was of the view that in future the NSQC be conducted in physical mode to ensure clarity in discussion of qualifications and other pertinent matters.

12.2.2. The committee directed that the awarding Bodies to ensure that inputs for the NSQC are shared well in advance for incorporation in the agenda. The last moment changes shall not be permitted.

12.2.3. The committee also observed that there are some sectors and some job roles



where there is high amount of duplication. NCVET should review such cases and develop a mechanism that duplication, to the extent possible can be minimized.

- 12.2.4. The chairman also emphasized that utmost care must be taken in planning, preparing and presenting of NSQC, since its one of the most important aspect of skilling life-cycle.
