Spot Auction of Obsolete furniture items <u>as scrap</u> will be conducted on 12<sup>th</sup> January 2024: 11:30 AM at National Institute of Electronics and Information Technology (NIELIT), Calicut (address given above)

Interested parties who are authorized or permitted by Central or State Pollution Control Boards for dealing with scrap items may participate in the Auction process. Parties may be allowed visual inspection of the items on 12 Jan 2024: by 10:00 AM to 11:00 AM.

Form for requesting permission to participate in the auction process and Price Quote form is attached herewith. Parties should satisfy themselves that they satisfy all conditions of the auction process, before participation.

Pre-Qualifications/Conditions:-

The participating parties should produce copy of the following documents:-

- Valid License or Authorization or Permission to deal with scrap items by Central pollution Control Board
  of the Government of Indial State Pollution Control Boards of State Governments. The validity of the
  license/authorization/permission should cover the period from the date of bid till disposal of the scrap
  items.
- 2. The license/authorization/permission should be complete enough to cover the type/nature and quantity of the scrap.
- 3. The bidder should have previous experience of disposing of scrap items of similar organization like Government Organizations/Engineering Colleges/Institutes etc. Proof of involvement in the form of certificates from the concerned Organizations should be attached with the bid form.
- 4. The bid should be valid upto 20th March 2024.
- 5. GST Registration Details.
- 6. Photo copy of PAN Card.
- 7. Duly Signed Authorization and photo Identity Card of the person (AADHAR card/PAN card/Driving License etc), who is representing the party, participating in the auction is required to be submitted before auction.
- The party should deposit <u>EMD of Rs. 10000/-</u> in the Bank Account No: 10401158037 (IFSC: SBIN0002207) and submit proof of deposit, before participation in the auction process.
