Price-Bid of the technically disqualified bidders will not be opened.

***(b) During bid evaluation, NIELIT may, at its discretion, ask the Bidder for a clarification of its bid. In case of erroneous/non-submission of following documents (as applicable):***

## **PART B: Scope of Work and Other Terms & Conditions**

**1. NAME OF WORK:** Renovation of office space including Civil, Electrical and LAN, CCTV & Networking works for NIELIT EC Centre Chitradurga.

**a. Objective:** To make the training Centre fully functional.

**b. Scope:** As defined below.

### **(i) Civil Work:**

1. Interior Renovation:

- Demolition:
- Removal of existing flooring as necessary.
- Wall Construction:
- Erecting new partition walls using gypsum board, glass, or other specified materials.
- Wall Finishing:
- Plastering, painting, and application of wallpapers or other finishes.
- Flooring:
- Installation of new flooring materials (tiles, carpets, vinyl, etc.) as specified.
- Ceiling:
- Installation of new false ceilings, including acoustic treatments where required.
- Doors and Windows:
- Replacement or refurbishment of existing/ blocked doors and windows.
- Other Finishes:
- Installation of moldings, skirtings, and other decorative elements.

### **(ii). Furniture Installation:**

- **Fixed Furniture:**

- Installation of built-in desks, cabinets, shelving units, and other fixed furniture items.

- **Movable Furniture:**

- Provision and arrangement of chairs, tables, desks, and other movable furniture items as per layout.

### **(iii) Electrical Work:**

1. **Lighting:**

- **Lighting Fixtures:**

- Installation of new LED lighting fixtures, including task lighting, ambient lighting, and emergency lighting.

- **Wiring:**

- Upgrading or installing new wiring systems for lighting and power distribution.

- **Switches and Outlets:**

- Installation of new switches, outlets, and control panels.

2. **Power Supply:**

- **Installation of speakers, microphones, and other audio equipment.**



### ### Summary

The scope of work for the renovation of the Centre includes comprehensive civil, electrical, and mechanical work. Civil work focuses on interior renovation, electrical work covers lighting, power supply, and safety systems, and plumbing systems. Low voltage systems are also addressed, ensuring efficient data and communication, security, and audio-visual systems. Each category ensures that the Center will be modern, functional, and equipped to support its intended use. However, all the incidental works even if not mentioned here or in BOQ is deemed to be included in the definition of scope of work. The party can visit the site at their convenience. No Extra Charges will be paid for the same.

### **PART C - SPECIAL CONDITIONS OF CONTRACT (SCC)**

*Special conditions will prevail upon the instruction to Bidders and other terms and conditions*

#### **1. Terms of Payment:**

- The invoice for payment shall be submitted to **Director I/C, NIELIT EC Chitradurga**. The payment will be made by NIELIT to the Identified Agency within 30 days from the date of receipt of invoice in accordance with the terms and conditions specified as below:

<b>Payment Terms</b>
40% payment against 1 <sup>st</sup> running bill, 40% against 2 <sup>nd</sup> running bill and balance 20% shall be made after completion and inspection of work and certification of bill by our site in charge.
Quantity of work as indicated in the Priced Schedule may vary depending on site conditions. Payment will be made for the actual quantity of work done and material supplied, as certified by NIELIT's authorized Person.

**The payment shall be processed only after receipt of following: -**

- (i) Unconditional Acceptance of LOA and signing of Contract Agreement as per RFP.
- (ii) Submission of **Contract Performance Guarantee (CPG)** in the form of Demand Draft / Pay Order / Bank Guarantee of 05% of the award Contract value within 14 days of issuance of LoA.

#### **Note-2:**

- (a) Successful bidder shall need to be mandatorily registered with the relevant Tax authority (ies) for the LOA items (works/ services etc where applicable), and furnish photocopy of their tax registration certificate and PAN along with each invoice.
- (b) Deposit of all statutory taxes, levies, etc. to Government authorities shall be the sole responsibility of the bidder and bidder shall indemnify NIELIT for any tax claims/problems, etc. with the statutory authority/Government or State authorities.
- (c) Applicable tax, TDS, etc. (as applicable) will be deducted by NIELIT as per Govt. policies, rules, regulations and guidelines, as prevailing at the time of making payment of invoices.
- (d) Benefit of any reduction in taxes & levies during the execution of contract shall be passed on to NIELIT by the bidder.
- (e) In addition to Performance Guarantee, a sum @ 2.5 % of the gross amount of each running Bill. Such deductions will be made and held by NIELIT by way of security Deposit ( SD ) and shall be released after successful completion of the work plus 12 Month.
- (f) All materials delivered inward to our site must be recorded and certified by NIELIT Security Personnel and an authorized representative of NIELIT Chitradurga before payment is released.

- 2. Timelines/ Contract Duration:** The total Contract Duration of the project would be 2 months.

### 3. Evaluation Criteria:

- (i) Bidder(s) has to submit the Price bid as per the “**Price bid format**” attached as **Annexure-I**. The prices have to be submitted online through CPP E-Procurement portal in dynamic excel form **only**. Prices submitted elsewhere in the bid/ offer shall not be considered valid. **Revealing of prices by the bidder in any form at any stage during the tender process shall lead to rejection of offer.**
- (ii) The Bid will be opened in the following stages: -
  - 1. Preliminary Scrutiny – verifying the EMD submitted along with the Documents asked of the Bidder.
  - 2. Technical evaluation – Bid to be evaluated based on eligibility Criteria
  - 3. Financial evaluation – Only the bidders who qualify the technical Round will be eligible for this stage.
- (iii) Splitting of order shall not be done. Entire work shall be awarded to L1 bidder.
- (iv) Price will remain firm till the execution of the contract.
- (v) Further, in case a party is not able to complete the work as per scheduled timelines, NIELIT reserves the right to hire another agency at the risk and cost of such non-performing bidder.
- (vi) In the event of tie in prices between two or more bidders, the bidder with higher turnover will be given preference in ranking & award. Avg. of last three financial years (i.e. - 2022-23, 2023-24 and 2024-25) shall be considered for arriving at turnover for comparison in such cases to break the tie.
- (vii) The initial technical evaluation shall be completed by the designated Tender Evaluation Committee.
- (viii) The financial bids of bidders who qualify in technical evaluation shall be opened online.
- (ix) The rate quoted shall include all costs and all taxes and duties applicable to the bidder as per law of the Central/State Government /Local Authorities.
- (x) Decision of the Tender Evaluation Committee would be final and binding upon all the bidders. The Tender Evaluation committee will open the Technical Bids followed by Financial Bids. In the event of specified date of Bid opening being declared a holiday, the bids shall be opened at the scheduled time and location on the next working day.
- (xi) The Bidder shall abide to the following in respect of reasonability of quoted price:
  - a. The rates quoted by them are at par with the prevailing market rates and are not more than the price usually charged for services of same nature/ class or description from any purchaser either Government or Private.
  - b. Services/Products/Goods supplied, will be of requisite specification and quality.

### 4. Action by NIELIT EC Chitradurga if L1 backs out

After opening of price bid, if L1 bidder i.e. the lowest scorer backs out, the bidder will be put on black list of NIELIT for a period of one year. During this tenure, the bidder will be barred from participation in NIELIT tendering process. However, bidder has to continue

the unexecuted work of the other prevailing work if any under the current running contracts. Simultaneously, the EPBG/ EMD submitted by such bidder against the subject tender will be forfeited. If bidder is exempted from submission of EMD, then the EMD amount will be adjusted from the payments due to the contractor against other running contracts. If there is no running contract of the bidder/ no payment dues of the bidder then NIELIT reserves the right to take any legal remedy as deemed fit to recover the penalty equivalent to EPBG/EMD amount through legal means.

## **5. Liquidated Damages and Penalties**

- (i) If the Identified Agency fails to perform the work within the specified time period or any extension granted thereof in writing, with respect to successful completion of work, the Identified Agency shall pay to NIELIT as liquidated damages and not as penalty, a sum of Half percent (0.5%) of the value of work of the Project for each week of delay or part thereof.
- (ii) The total amount of liquidated damages for delay under the Project shall be limited to a maximum of Ten percent (10%) of the total value of work of the Project.
- (iii) The Liquidated Damage will not be applicable for the period if delay is not on Identified Agency (ies) part. Alternatively, NIELIT may cancel the prejudice to his right under the alternatives mentioned above.
- (iv) Alternatively, NIELIT reserves the right to procure the services from elsewhere at the sole risk at the cost of successful Identified Agency and recover all such extra cost incurred by NIELIT in procuring the services from resources available including Empanelment Performance Guarantee or any other sources etc. Further, if any extra cost is incurred by NIELIT due to delay in work completion by the party beyond the completion time as per Letter of Award, the same shall also be recovered invoice, Empanelment Performance Guarantee, etc.

Alternatively, NIELIT may cancel the order completely or partly without prejudice to his right under the alternatives mentioned above.

## **6. PERIOD OF VALIDITY OF BID**

Bids shall remain valid for a period of 180 days after the closing date prescribed by the NIELIT EC Chitradurga for the receipt of bids. A bid valid for a shorter period may be rejected by the NIELIT as being non-responsive. In exceptional circumstances, the NIELIT EC Chitradurga may solicit the bidder's consent to an extension of the bid validity period. The request and response thereto shall be made in writing thro' letters/ E-mails. If the bidder accepts to prolong the period of validity, the bid security/EMD shall also be suitably extended. A bidder may refuse the request for Bid Validity Extension without forfeiting its bid security. A bidder granting the request will not be required nor permitted to modify its bid.

## **7. Adjudicator:**

Adjudicator under the contract shall be appointed by the Appointing Authority i.e. Director –I/C (NIELIT EC Chitradurga). If the bidder does not accept the Adjudicator proposed by NIELIT, it should so state in its bid form and make a counter proposal of an adjudicator. If on the day the contract agreement is signed, the NIELIT and contractor have not agreed on the

appointment of adjudicator, the adjudicator shall be appointed, at the request of either party, by the appointing authority specified.

## **8. Arbitration:**

Arbitration shall be carried out as per Arbitration Act 1996 and its subsequent amendment. The Contract shall be governed by and interpreted in accordance with the laws in force in India. The courts of Chitradurga shall have exclusive jurisdiction in all matters arising under the contract.

## **9. Contract Performance Guarantee**

Within Fourteen (14) days of the receipt of notification of award from NIELIT EC Chitradurga, the successful bidder shall furnish the CPG in the form of Demand Draft/ Pay Order or Bank Guarantee for **05%** of total contract value. The Bank Guarantee must be valid to cover the Contract Period + Warranty Period /Defect Liability Period (As applicable) + Two Months Claim Period.

Any delay in submission of CPG/SD beyond such permissible duration shall be deemed as accruing of financial benefit to the supplier and NIELIT EC Chitradurga shall take necessary interest penalty recovery action (interest @ SBI's MCLR + 2 % on the CPG amount) for the period of delay from the payments due to the supplier, to be deducted from the first invoice submitted by the contractor/supplier. However, this provision does not bind NIELIT EC Chitradurga in any way from proceeding against the supplier (including forfeiture of EMD, cancellation of the LOA, etc.) for noncompliance towards non-submission of the CPG/SD.

Bank guarantee shall be from any Nationalized Banks/other scheduled private banks as per RBI list. NIELIT EC Chitradurga shall at his discretion have recourse to the said Bank Guarantee for the recovery of any or all amount due from the bidder in connection with the contract. This shall include the recovery, if any, against the Penalties applicable during Repair and maintenance period (if applicable) as brought out under relative Clause under Liquidated Damages.

Failure of the Successful Bidder to comply with the requirements of Bid Document shall constitute sufficient grounds for the annulment of the award and forfeiture of the Contract Performance Guarantee.

If any shortfall in performance is observed, as per the criteria mentioned in this bid, NIELIT EC Chitradurga shall have right to INVOKE BANK GUARANTEE. - a. Compliance of all the statutory requirements as may be required w.r.t the activities to be performed to execute the scope of work under the subject LOA is in the scope of bidder only.

The party unable to carry out its contractual obligations shall immediately advise the other party of the commencement and the termination of the circumstances preventing the performance of the contract. A certificate issued by the respective Chamber of Commerce shall be sufficient proof of the existence and duration of such circumstances.

**18. Defect Liability Period:**

Warranty: -The defect liability period for the work is 1 year from the date of completion of work.

**19. Deviations/Variations in Quantities and Pricing**

The work defined/quantities provided in the "Schedule of Quantities/BOQ" are based on estimates and are meant to indicate the extent of the work and to provide a uniform basis for tendering. Any variation, either by addition or omission, shall not invalidate the contract.

A. b. If the additional, altered, or substituted work includes any class of work for which rate(s) are not specified in the contract/work order, the rate(s) for such items shall be determined by the Authorized-In-Charge as follows:

1. The rate for the extra item shall be derived from the rate for a similar or near-similar item of work available in the agreement schedule of work, or by analysis of rates as below. The lower of the two shall be considered. The Schedule of Rates (SOR) of CPWD/PWD may also be used.

In cases of composite item rate tenders, where two or more schedules of quantities for similar item descriptions may form part of the contract, the applicable rates shall be taken from the Schedule of Quantities of the relevant part in which the deviation is involved. Failing this, the lowest applicable rate for the similar item of work in the other schedule of quantities will apply.
